The registered contractors may obtain information required to issuance of Digital Certificate from *e-Procurement system Help Desk No. 1800 258 2502* (Toll free) (From 9.00 AM to 11.00 PM) or through Email ID helpdesk.cgeproc@gmail.com.
3. For submitting the bids online, the contractors/bidders are required to make online payment using the electronic payments gateway service Bid Hash Submission Fee as mentioned above The different modes of electronic payments accepted on the e-Procurement System is available and can be viewed online on the e-Procurement Website (<http://eproc.cgstate.gov.in>).
4. Tender Download, Submit Bid Hash online, Submission of Bids, EMD and other Documents and other activities will be governed by the time schedules given under -Key Dates.
5. Conditions related to e-Procurement are furnished in Guidelines to bidders EPS v1 of tender document and will overrule other conditions wherever applicable/relevant.
6. The tender documents can be downloaded free of cost from the portal. (website) <http://eproc.cgstae.gov.in> directly and shall be submitted online only after making the payment of Bid submission fees online.  3. Copy of Valid GST Registration Certificate in State of Chhattisgarh
 4. Copy of Valid Bank Solvency Certificate (minimum 15% of tender)
 5. Copy of Income tax Clearance Certificate. (Last 03 Financial Year).
 6. Affidavit in Annexure-13
 7. Tender Document Fee DD (DD at CMO NPP, Mandir Hasaud)
 8. EMD Amount Only Paid by OFFLINE (BY FDR ON NAME OF Chief Municipal Officier Nagar Palika Mandir Hasaud ONLY)

14. Chief Municipal Officer Municipal Council Mandir Hasaud have to right of rejection and approval of the tender.
