- Upload scanned copy of Tender Fee of ₹2400/-in the form of Demand Draft only (Cash not acceptable) in favour of Executive Engineer, Sachivalaya Complex Electrical Division, Gandhinagar payable at Gandhinagar from any Nationalized / Scheduled Bank. (DD for Tender Fee must be purchased from the account of Bidder)
- Upload scanned copy Bid Security/Earnest Money Deposit of ₹67,000/-in the form of FDR (with a validity period of not less than 165 Days) / Bank Guarantee from Nationalized/ Scheduled Bank in favour of Executive Engineer, Sachivalaya Complex Electrical Division, Gandhinagar payable at Gandhinagar **OR** Exemption Certificate is Valid (FDR for EMD must be purchased from the account of Bidder)
- Upload scanned copy Bank Solvency (25 percent of estimated cost put to tender i.e. ₹16,56,355.92) issued from Nationalized/Scheduled bank of 2026
- Upload Scanned copy of Permanent Account Number (PAN) issued by Income Tax Department
- Upload Scanned copy of GST Registration Certificate
- Upload scanned copy of D and above category registration (Electrical)
- Upload Scanned copy of Annual Turnover Statement certified by C.A. of any one of last five financial year i.e.2021-22 to 2025-26 updated to the current financial year shall be more than ₹3,97,52,542.08
- Upload Scanned copy of valid Electric contractor licence.
- Upload Scanned copy of Experience in Form -3A for one similar Completed work (i.e. AV System work or Digital Conference System) having completion cost not less than ₹26,50,169.47 (40 Percentage of the amount put to tender for the proposed Work)
