## **1.0 INTRODUCTION**

Documents for contractor's pre-qualification are invited for project namely **Work of Widening, Strengthening and Resurfacing of various road as and when required or in emergency under Panchayat R&B Division, Junagadh (Annual Rate Basis)** General contractors, backed up specialists who wish to bid for the contract, should apply for qualification as set out in this document. The other tender document i.e. price bid with technical details will be opened subsequently only of those parties selected by the evaluation committees (R&B Department Government of Gujarat) as having necessary qualification / suitability to perform the contract satisfactorily. Tender Documents, Technical Bid along with "Price Bid" invited on line by E-Tendering to contracts/ firms. Only those bidders shall bid whose names are borne on the approved list of registered contractors in the **AA-Class** with **Special Category-I (Road)** with Gujarat State R&BD / W.R.D. The contractor's who are registered in appropriated category of C.P.W.D., M.E.S., Railways and Indian State Governments, can also bid provided the bidder produce such registration certificate at the time of bidding and obtain registration in required class and category from the Gujarat State R&BD / W.R.D. before issuing Work Order. Bidder will solely be responsible for obtaining the required registration.

A Pre Bid conference shall be held on - **-2025** at 12.00 P.M. in the office of the Superintending Engineer, Rajkot Panchayat (R&B) Circle No.2, Rajkot with all intending contractors. Any clarification or further details regarding work will be given in this meeting and minutes of this conference shall be noted and shall be circulated to all tenderers, the minutes of the Pre-Bid Conference shall be considered as part of the tender documents.

## **8.0 CONDITIONS OF CONTRACT:**

Condition of contract will be as per standard documents i.e. SBD Tender Form and other additional specified and modified conditions as needed to suit the local condition.

The Project will be governed as per the relevant Indian act in force from time to time. All works will be conforming to the Indian Standards or other equivalent standard mentioned in the contract documents as approved by the Engineer in charge.

The law governing the contract will be the Indian law. This work is proposed to be carried out from plan allocation of the state.

## **9.0 INSTRUCTION TO APPLICANTS:**

- 9.1 A bidder may be pre-qualified for the works under this tender if the requisite technical, financial and experience criteria are fulfilled.
- 9.2 One firm can be pre qualified only once in its own name. **No Joint venture will be allowed.**
- 9.3 Pre qualification Questionnaire completed in all respect should be submitted to on-line not later than IST 16.00 Hours on dated. - **-2025** on web site at **rnb.nprocure.com**

#### **9.4 SUBMISSION OF TENDER:**

D.D. for Tender fee & EMD valid Registration **Special Category-I (Road)** with **"AA" Class** certificate, Valid Bank Solvency Certificate 20% of Estimate Cost and Valid Drum Mix Plant Certificate shall be submitted in electronic format only through on line (by scanning) while uploading the bid. This submission shall mean that E.M.D., Tender Fee valid Registration Special Category-I (Road) with "AA" Class certificate, Valid Bank Solvency Certificate 20% of Estimate Cost and Valid Drum Mix Plant Certificate are received for purpose of opening the bid. Accordingly offer of those shall be opened whose E.M.D. & tender fee, valid registration Special Category-I (Road) with "AA" Class certificate, Valid Bank Solvency Certificate 20% of Estimate Cost and Valid Drum Mix Plant Certificate are received electronically. However for the purpose of realization of D.D., bidder shall send to S.E. at the time of tender opening or send the same in original through R.P.A.D. so as to reach Executive Engineer, Panchayat (R&B) Division, within 7 days from the last date of opening. Penaltative action for not submitting D.D. and FDR in original to Executive Engineer by bidder shall be initiated and penalty like abeyance of registration and cancellation of E-Tendering code for a period of one year as Government Circular Date.27-11-08. F.D.R. for Exemption Certificate is not necessary. However exemption certificate shall to be submitted electronically through online.

Any documents in supporting of bid shall be submitted in electronic format only through online (by scanning etc) and the same shall be furnished within stipulated time otherwise further processing will be carried out in absence of above and the bidder shall be liable for any consequence.

**9.5** The costs incurred by the bidders in making this offer, in providing clarification or attending discussions, conferences or site visits will not be reimbursed by the Employer or the Engineer-in-charge.

**9.6** Additional details for pre-qualification shall be submitted in proper format and incomplete offers shall be rejected. Following documents duly certified along with application and tender fee.

- (a) Registered Special Category-I Roads & "AA" Certificate.
- (b) Valid Bank Solvency Certificate 20% of Estimate Cost
- (c) List of works on hand.
- (d) Partnership Deed.
- (e) Valid power of attorney.
- (f) In case of limited company registration certificate as per Indian Company's act and article of association and memorandum of association with details of board or directors etc.
- (g) Any other documents required for pre-qualification.
- (h) Valid Drum Mix Plant Certificate

**9.7 LANGUAGE TO BE USED :-**

The language for submission of bid should be in English.

**9.8 UPLOADING OF BID :-**

The "Pre Qualification Bid" will be open on date - **-2025** after IST 12:00 Hours (and if not possible then on the next working day) in the office of the **Superintending Engineer, Panchayat R&B Circle No.2, Rajkot** and will be submitted to screening committee for approval.

**9.9** No withdrawal under any circumstances is allowed / grated after opening of Pre-Qualification Officer. Offers shall be Validity period of tender 120 days After the Deadline date for bid submission.

**9.10** The enclosed schedules should be filled in completely and all questions should be answered, if any particular quarry is not relevant it should be stated as "NOT APPLICABLE".

**9.11** Financial data, project costs, value of works etc. should be given in Indian rupees only.

- 9.12 For any clarification, the Engineer-in-charge i.e. Executive Engineer, Panchayat Road and Building Division, Junagadh to be contacted by having appointment on working day.
- 9.13 The contractors registered **Special Category-I Roads & "AA"** Certificate issued by R&B Department only in the State of Gujarat or equivalent class in other state or C.P.W.D. or equivalent category but not having registered **Special Category-I Roads & "AA"** Certificate. Registration shall obtain the same from R&B Department in the State of Gujarat before issuing work order. The price bid will be opened only of those contractors who pre-qualified.
- 9.14 If the application is made by a proprietary firm, it shall be signed by the proprietor above his full name and the full name of his firm with its current address.
- 9.15 If the application is made by a firm in partnership, it shall be signed by all the partners of the firm, above their full names and current addresses or by a partner holding the power of attorney of the firm by signing of the application in which case a certified copy of the power of attorney shall be accompany with application. A certified copy of the partnership deed, current address of the firm and the full names, and current address of all the partners of the firm shall also accompany with the application. **No Joint venture will be allowed.**
- 9.16 If the application is made by limited company or a limited corporation, it shall be signed by a duly authorised person holding the power of attorney for signing the application in which case, a certified copy of the power of attorney shall accompany with the application. Such limited company or corporation will be required to furnish satisfactory evidence of its existence before the contract is awarded.
- 9.17 The information furnished must be sufficient to show that the applicant (along with the all parties) is a capable in all respects to successfully complete the envisaged contract works strictly on the basis of the applicant, (along with all parties) having already carried out satisfactorily works of similar size nature and complexity.
- 9.18 The bidder while submitting the tender for the works shall be required to provide satisfactory evidence in respect of information's furnished by them in their application for prequalification regarding their structure and organisation, financial position/arrangement, resources of the firm including personals and equipment's, experiences as well as works on hand etc. The applicants attention is explicitly drawn to the fact that, even after the pre-qualification of potential bidders has already carried out, all bidders shall include statement of the change that may have occurred since prequalification with particular reference to the various items listed above and that further more contract work shall be awarded to successful bidders only on the basis of careful scrutiny of all the above information furnished by the applicant.



**9.19** The applicant is expected to have visited the project site before submitting pre-qualification bid and tender documents. No cost for any clarification or visit to site. etc. will be reimbursed by the employer.

**9.20** While submitting the schedule duly filled by the applicant shall submit the latest copies of brochures and prequalification documentation giving more information about the firm and all the members.

**9.21** The prequalification documents received from the Superintending Engineer, Rajkot Panchayat R&B Circle No. 2 Rajkot shall be considered by a screening committee consisting of the following.

**9.21.1** The committee shall ascertain whether the bids,

- i) Meet the eligibility requirements.
- ii) Have been properly prepared and signed:
- iii) Contain all the details called for and are in proper format.
- iv) Are accompanied by required authorisation and
- v) Are otherwise generally in order.

**9.21.2** The committee will evolve a suitable methodology for making assessment of the suitability of the firms who have applied for pre-qualification which will also include the following items.

**Prequalification Criteria for the Work of Widening, Strengthening and Resurfacing of various road as and when required or in emergency under Panchayat R&B Division, Junagadh (Annual Rate Basis)**

**9.21.2 (I) Eligibility**

- (a) I. Bidder can be a firm having valid registration as per **Para 9.21.2(III)(a)** herein below.

**9.21.2(II) Qualification Criteria**

**(a) Annual Turn Over**

- i. Annual turnover of any one of the last five financial years i.e. from **2020-21 to 2024-25** updated to the current financial year shall be more than **Rs.2510.93** Lacs
- ii. For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement factors shall be as given in **Para 9.21.2(IV)** herein below.

**(b) Successful Experience**

Bidder must have as prime contractor or as nominated (approved by employer) subcontractor successful experience as follows

- i. At least one similar work having updated completion cost not less than **Rs.1004.372** Lacs (40% of the amount put to tender of the proposed work)
- ii. Such work must have been completed within last five financial years. i.e. from **2020-21** to till the due date of bid for the proposed work.
- iii. A work would qualify as similar work only if it meets with definitions given as Appendix-A
- iv. For updating completion cost of the work to the current financial year, procedure narrated in **9.21.2(II)(a)(ii)** shall mutatis mutandis apply.

**(c) Bid Capacity**

- i. The bidder must have Available Bid Capacity (ABC) more than **Rs.2510.93** Lacs.

$$ABC = 2 * A * N - B$$

Where

**A** is the maximum updated total amount of works executed in any one year of the last five financial years i.e. from **2020-21 to 2024-25**

**N** is the number of years prescribed of completion of the proposed work (**1.0 Year**)

**B** is the amount of the existing commitments and ongoing works to be discharged during time interval of **N** years from the bid due date.

For the purpose of updating amount of works executed in any year.

Procedure narrated in Para **9.21.2(II)(a)(ii)** shall mutatis mutandis apply.

Existing commitments shall include all such works for which letters of acceptance of the tenders have been received by bidder till the date on which bidder has submitted his bid for the proposed work.

### **9.21.2(III) Other Requirements**

#### **a. Bidder's Registration**

- i. Only those bidders shall bid whose names are borne on the approved list of registered contractors in the **AA-Class** with **Special Category-I (Road)** with Gujarat State R&BD / W.R.D.
- ii. The contractor's who are registered in appropriated category of C.P.W.D., M.E.S., Railways and Indian State Governments, can also bid provided the bidder produce such registration certificate at the time of bidding and obtain registration in required class and category from the Gujarat State R&BD / W.R.D. before issuing Work Order. Bidder will solely be responsible for obtaining the required registration.

#### **b. Litigation History**

The applicant should provide accurate information on litigation and / or arbitration resulting from contractors completed or under execution by him over the last five years. A consistent history of arbitration awards / judgments against the applicants or any partner of a joint venture may result in disqualification for proposed work. If the details of Litigation History is hidden by the applicant and later on it comes to knowledge of the employer the bidder shall be disqualified for the proposed work and other appropriate actions shall be taken against the bidder.

**c. Machinery / Equipment**

Bidder shall have to assure availability of machinery / equipment's in working condition as per Appendix-B. If bidder fails to provide proof of assured availability of required machinery, he will be disqualified for the proposed work. Machinery ownership document or lease / hire agreement for the work under tender shall be considered as valid proof for assured availability.

**d. Bidding in E-tendering**

- i. Submission of application must be through-e-tendering i.e. Electronic from.
- ii. Bidders shall have to submit the bid in E-Tendering from only.
- iii. Bids of those bidders who have submitted all information, statistical details as required in the bid documents through E-tendering will only be considered. If the employer desires any clarification, for verification / clarification, ambiguity of difference found in the documents / statistical details submitted online (by E-tendering) by the bidder the same shall be furnished within stipulated time otherwise further processing will be carried out in absence of above and the bidders shall be liable for any consequence.
- iv. No bidder can participate in more than one bid for proposed work.

**e. Submission of documents**

- i. Following documents / papers shall from part of the bid.
  1. ~~JV agreement (when bidder is JV) clearly indicating the name of lead partner and percentage financial participation of each partner. JV agreement must also demonstration responsibility of each partner. The JV agreement should be so signed as to be legally binding to all partners, jointly and severally.~~
  2. Annual turnover certificates issued by chartered accountant for last five financial years.
  3. Form 3A issued by employer to substantiate successful experience of similar work. When employer of similar work is not a government, following need also to be furnished.
    - a. Self attested copy of Work Order.
    - b. Self attested copy of agreement.
    - c. Self attested copy of Completion Certificate.
    - d. Self attested copy of Final Bill.
    - e. Self attested copy of TDS Certificates.

- b. Self attested copy of letter of permission given by employer for subletting the work.
4. Existing commitments and ongoing works as per Schedule-E.
5. Litigation / Arbitration history.
6. Proof of assured availability of required Machinery / Equipment.
7. An undertaking for truthfulness of information furnished.
- ii. Any information, data, statistics etc. which are not related to bid document will not be considered in evaluation even though furnished by the applicant.
- iii. In accordance with stipulation of Para **9.21.2.(III)(d)(iii)** Employer reserves the right to call any information / document which is mandatory, essential and critical for the purpose of evaluation. Any information provided by the applicant after last date of Electronic submission will not be considered in evaluation, unless except the employer has specifically asked for any information / document, which is mandatory, essential and critical for evaluation of PQ document. If required information is not furnished within stipulated time, proposal will be liable for rejection.
- iv. If any of the information provided by the bidder is found false during scrutiny or at the later stage, his EMD shall be forfeited and he shall be disqualified for the proposed work. In case when bidder has furnished exemption certificate in lieu of EMD, an amount equal to EMD shall be appropriated from his FDR pledged to avail of exemption certificate. If any of the information provided by the bidder is found false after award of work, the performance security of the bidder shall be forfeited and the contract shall be terminated.

#### **9.21.2(IV) Escalation Factors**

Following enhancement factors will be applied to annual turnover and completion cost of works to bring them to the base year. The current Financial Year in which bid is invited shall be considered as the base year.

# **TECHNICAL SPECIFICATIONS**

## **1.0 PREAMBLE**

1.1 The Technical Specifications contained herein shall be read in conjunction with the other Bidding Documents as specified in this Volume.

## **1.2 Site Information:**

1.2.1 The information given here under and provided elsewhere is given in good faith by the Employer but the Contractor shall satisfy himself regarding all aspects of site conditions and no claim will be entertained on the plea that the information supplied by the Employer is erroneous or insufficient.

## **2.0 GENERAL REQUIREMENTS**

The technical specifications in accordance with which the entire work described herein after shall be constructed and completed by the Contractor shall comprise of the: “*SPECIFICATION*”

2.1 Though “*SPECIFICATION*” for each item are attached with tender they are based on following:

- (1) “SPECIFICATONS FOR ROAD AND BRIDGE WORKS” (Fourth REVISION printed in year 2001) issued by the Ministry of Road Transport & Highways (MORT&H), Government of India and Published by the Indian Roads Congress, hereinafter to as MORT&H Specifications.
- (2) The General Technical Specifications for Road Works
- (3) The General Technical Specifications for Bridge Works
- (4) The General Technical Specifications for Asphaltic Works
- (5) The General Technical Specifications for Building Works

Note (2) To (5) are Conventional Specifications Booklets usually attached for (R&B) Works.

- 2.2 If, a particular clause (which is incorporated in “*SPECIFICATION*”) of specification booklets (1) To (5) above is Amended / Modified / Added upon then the Amendment / Modification / Addition shall supersede the relevant clause incorporated in “*SPECIFICATION*”
- 2.3 In so far as Amended/Modified/Added Clause may come in conflict or be inconsistent with any of the provisions of the MORT&H Specifications under reference, the Amended/Modified/Added Clause and the additional specifications shall always prevail.
- 2.4 In the absence of any definite provisions on any particular issue in the aforesaid Specifications, reference may be made to the latest codes and specification, of IRC and BIS in that order. Where even these are silent, the construction and completion of the works shall conform to sound engineering practice as approved by the ‘Engineer’ and, in case of any dispute arising out of the interpretation of the above, the decision of the ‘Engineer’ shall be final and binding on the Contractor.
