4.3	Offers submitted without digitally signed will not be accepted.
4.4	Offers in physical form will not be accepted in any case.
5.0	Submission of Tender Fees, Bid Security and other valid Documents:
5.1	Tender Fee : Rs. 900/- (Rupees Nine hundred only) by Demand Draft in favour of "Executive Engineer, Godhra (R&B) Division, Godhra" , payable at Godhra from any Nationalized/Scheduled Bank except Co-operative Bank.
