### **GENERAL CONDITION FOR CIVIL WORKS**

The provisions detailed below are applicable to items of work and are deemed to be integral part of the detailed specification of items of work and are to be followed strictly.

- (a) It shall be distinctly understood that contract rate of the item is for the work completed in all respect and shall invariably be inclusive of the cost of follows.
- (b) Fabricating, erecting, handling conveying, placing and keeping in position of materials.
- (c) Consolidation, vibrating, curing, finishing etc. whenever the nature of the item is obviously indicative of the same.
- (d) Racking as directed to all concrete surface except those which are to remain as "off the form exposed surface" to provide proper bond to the abutting masonry or finishing as the case may be.
- (e) All fixtures and fastening required for satisfactory completion of item of work even though not specifically indicated.
- (f) All works tests and tests of material required to be carried out as specification or as required to be carried out in the opinion of the Engineer in charge.
- (g) Conveyance of materials provided in Schedule 'A' from the place of delivery to the site of work and their preservation in good state while in use or till return to the department, if found surplus.
- (h) The contractor shall have to give an undertaking on appropriately stamped paper a guarantee for items of water proofing to the Department in the manner and form as prescribed below.
- (i) Reference to specification of materials are given in the details specification of items of work in the form as mentioned below i.e. M.5 means M.5 of specification of materials.
- (j) The agency has to submit mix design for different grades of controlled concrete at his own cost and shall be got approved by Engineer in charge.

In case of any errors or omissions in such numbers the relevant specifications of items should be adopted for execution of work as directed by Engineer in charge without any extra cost to Government.

The props use for centering shall be of M.S. pipe and it should be pressed with M.S. angle or flats.
