Incomplete tender or tenders which are not fulfilling any of the above conditions and those stated below shall become liable for the rejection :-

- (1) If the tenderer proposed any alteration in the work specified in the tender or specifications of materials or scope of work or any other condition.
- (2) If any of the pages of the tender are removed or replaced.
- (3) If any correction or erasures are made by him in the tender.
- (4) If earnest money or demand draft for the full amount is not attached with the tender.
- (5) If all the corrections and additions or pasted slips are not initialed by the tenderer.
- (6) If in the case of firm, each partner thereof does not sign or the signature is/are attested by the witness on page No.2 of the tender in the purpose.
- (7) It must be clearly and strictly understood that the conditions of the contract and specifications given are to be rightly enforced and no deviation the grounds of customs prevailing to be allowed.
- (8) The tender for the work shall remain for period of 120 days from the date of opening of the tender for this work and that the tenderer are not allowed to withdraw or modify the offer of his during this period.
- (9) The tenderer whose rates are acceptable shall have to enter into (FORM-B-1) and pay the required Security Deposit of 3% of the

contract value in form of N.S.C. of Narmada Bond within 10 days on receipt of letter of acceptance, failing which, earnest money paid will be forfeited.

- (10) The tenderer should clearly offer percentage in figure as well as in words in the schedule. In case of no reduction, estimated rates should be clearly mentioned.
- (11) The rates shall be quoted by the tenderer inclusive of all taxes, levies etc. as applicable from time to time.
- (12) The rate should be offered after considering the place of the delivery as shown in the schedule and specified in the condition. No extra conveyance charges will be borne by the Department.
- (13) The earnest money draft/FDR must accompany with the sealed cover. The tender will not be considered, if it is received after opening of the tender. The name should be clearly indicated on the reverse of a Demand Draft.
- (14) The acceptance of tender will rest with the competent authority and does not bind himself to accept the lowest and also reserve the right to reject any or all the tender without giving any reason thereof.
- (15) If the tendered rates are found unworkable that shall be liable for rejection and for any complaint thereof will not be accepted.
- (16) Material supplied by the supplier if found inferior quality, the same will be rejected out-right and for rejected material, payment will not

be made under any circumstances and rejected materials shall have to be removed from site of work/store at supplier's risk and cost.

- (17) The rates are approved for one year and hence supplier shall have to supply the materials on road site as per supply order by concerned Deputy Executive Engineer or otherwise, action shall be taken as per C - 1 - (2) "B-1" Tender.
- (18) One (1) percent of the estimated cost shall be recovered from each Running Bills of the contractors for testing the quality of materials and works, irrespective of actual expense incurred by Department.
- (19) The Executive Engineer reserves his right to place repeat orders for the quantities up to 50 percent of the quantities for each item as shown in this bid documents within a period of six months from the date of expiry of contract subject to terms and conditions herein provided as agreed to by the contractor under this tender mentioned above and he shall accept the same. Non-compliance of repeat orders shall be dealt with under clause "2" of this contract.
