4.3	Offers submitted without digitally signed will not be accepted.
4.4	Offers in physical form will not be accepted in any case.
5.0	Submission of Tender Fees, Bid Security and other valid Documents:
5.1	Tender Fee : Rs.900/- (Rupees nine hundred only) by Demand Draft in favour of "Executive Engineer, Bharuch (R&B) Division, Bharuch", payable at Bharuch from any Nationalized/Scheduled Bank except Co-operative Bank. Demand draft issued after the last date of submission of Bids will not be considered or accepted.

In form of B.G., first Rs. 50,000/- in form of DD or FDR & remaining amount in form of Bank Guarantee.
