

Prequalification Criteria

Name of Work : Annual Rate Contract for Providing Temporary LED Screen, Videography under Ahmedabad Electrical Division No.1, Ahmedabad. (Year 2026-27)

Estimated cost Rs.15,00,000/-

1. Kindly attach scan copy of Tender Fees Rs. 900/- (only Demand Draft is Valid) in Favour of Executive Engineer, Ahmedabad Electrical (R & B) Division No.1, Ahmedabad.
2. Kindly attach Scan Copy of E.M.D cum SD Rs. 2,00,000/- in FDR Format only (Not less than 365 days) In Favour of Executive Engineer Ahmedabad Electrical (R&B) Division No.1, Ahmedabad.
3. Valid copy of Income Tax PAN Card
4. Undertaking by agency ensuring access/ availability of credit facilities up to 25 percent of the value of the Contract as per SBD
5. The bidders should have GST registration. (Certified copy of registration).
6. Valid Electrical Registration Certificate in appropriate class (E-1 or Above) (Receipt of renewal/registration is not valid)
7. Latest valid license of Electrical Contractor issued by the Licencing Board, Energy & Petrochemical Department. At the time of work order award, agency must submit valid Electrical Licence Renewal Receipt will not be consider at the time of award work order.
8. Essential experience in Form 3A issued by competent authority (which is online submitted by the bidder) of **(A)** At least One similar work (i.e. Temporary LED Screen, Videography and multimedia setup in Govt. program successfully completed) having updated completion cost not less than Rs. **7,50,000/-**. **(B)** If the work is Completed before Nov-2023, then 18 Percentage GST Amount will be deducted from the amount shown in Form-3A which is online submitted by the Bidder. If the work is completed in OR after Nov-2023 then the full amount as per the Form-3A Which is Online submitted by the bidder will be considered.

(C) Such Work must have been completed in any one year of last five financial year i.e. from 01/04/2021 till the due date of bid for this work.

Note: work order & Bill pertaining to form 3A submitted with online may be asked to present if required by the tendering authority.

Similar work means having an experience of Temporary LED Screen, Videography and Multimedia Setup for Various Government function, in the state of Gujarat. Only LED and Videography and multimedia setup.

If the Work (shown in Form-3A) carried out/Organized by Government department, then only it will be considered/accepted.

If submitted Form 3A is combined of LED Screen, Videography and Multimedia Setup then breakup of each should be submitted along with certified copy of bill and Agreement.

9. Annual turnover in any one of the last Five Financial years (2021-2026), ending 31st march of the previous financial year, should be at least 2 times of the estimated cost (i.e. Rs.30.00 Lakh) Bidder has to submit turnover certificate which is verified and authorized by Chartered Accountant. The UDIN mandatorily mentioned on the turnover certificate.
10. Agency has to submit declaration on Rs. 300 stamp paper that it is not blacklisted by any government department in last five year. (Annexure-B)
11. Agency has to submit undertaking on 300 stamp paper (Annexure-A)
 - The experience certificates in form 3(A) issued by Event Management company or private organization, function will not be considered. Sublet work will not be considered. many works clubbed together such as annual rate contract works will not be considered. In support of 3A form of other than R&B Department, Agency has to submit bill copy & agreement copy of VIP/VVIP program. Other than state government program such as board, Nigam, corporation experiences will not be considered.
 - Scanned copy of all the Documents mention in the PQ Criteria must have to be submitted online. Otherwise bid will not be considered/accepted.

- The bidders who do not furnish full details and all the documents as listed above or furnish incomplete or insufficient details or documents will be treated as non-responsive & their price bid will not be opened. The documents as listed above shall be submitted in electronic format only through on line (by scanning) while uploading the bid. This submission shall mean that E.M.D. & tender fee are received. Accordingly offer of those shall be opened whose E.M.D. & Tender Fee is received electronically. However, for the purpose of realization the bidder shall send the DD/FDR in original through R.P.A.D./Speed Post so as to reach Executive Engineer, Ahmedabad Electrical (R&B) Division No.1, Ahmedabad within 7 Days from the date of Opening. Punishable action for not submitting F.D.R/D.D. in original to Executive Engineer, by bidder shall be initiated.

12. **ESCALATION FACTORS**

Following enhancement factors will be applied to annual turnover and completion cost of works to bring them to the base year. The current financial year in which bid is invited shall be considered as the base year.
