1. The Contractor whose names are registered in the approved contractors of any State or Central R&B Dept./PWD and the Contractors Registered in **E2 - Class and above** shall be submitted by a contractor or by a firm of contractors.
2. Contractor must have Special Category Road III.
3. The scanned copy of the contractor's registration, necessary bank **solvency of Rs. 0.38 Lac of the Current Calendar year** will have to be uploaded with others required documents. No Exemption is allowed in Solvency Certificate.
