1. The Contractor whose names are registered in the approved contractors of any State or Central R&B Dept./PWD and the Contractors Registered in E-1- Class and above shall be submitted by a contractor or by a firm of contractors.
2. The scanned copy of the contractor's registration, necessary bank solvency of Rs. 6.00 Lac of the Current Calendar year will have to be uploaded with others required documents. No Exemption is allowed in Solvency Certificate.
3. Bidder must have an experience of having successfully completed during last three years should be either of the following amount in Govt. / Semi Govt. / PWD Department & Form 3A for the same must be submitted by contractor online and physical submission.
 - One similar work (Asphalt Road) completed costing not less than the amount equal to 80% of the estimated cost. (i.e. 80% of Rs. 30.00 Lac)
or
 - Two similar work (Asphalt Road) completed costing not less than the amount equal to 50% of the estimated cost. (i.e. 50% of Rs. 30.00 Lac)
or
 - Three similar work (Asphalt Road) completed costing not less than the amount equal to 40% of the estimated cost. (i.e. 40% of Rs. 30.00 Lac)
4. An average annual turnover of the firm should not be less than 30.00 Lacs for

last Three Financial Years. An attested copy of C.A. Certificate and I.T.Return copy of last three years should be enclosed.
