- All the information shall have to be filled in the prescribed statement wherever mentioned.
- All the details required in the prescribed statement shall have to be duly filled up. No information shall be left out. Relevant item without required information shall not be considered for evaluation.
- All the required attachments shall have to be invariably attached. Relevant item, without required attachment shall not be considered for evaluation.
- VAGHODIYA Nagarpalika reserves the right to accept any one or reject all of the offers/tenders without giving any reasons thereof.
- The details given by the applicants in the post qualification documents will be evaluated as per qualifying criteria item No. 4. ### **3.1 EXPERIENCE**

- a) The Applicant shall provide evidence that their firm has been actively engaged in the civil works construction of such type of civil work during the last 5 years in the role of prime contractor/partner. The work completed as sub-contractor shall not be considered for evaluation.
- b) Particular Construction Experience  
The applicant shall provide evidence that it has successfully completed or substantially completed within the last Five years i.e. from 01/06/2021, the works may have been executed by the Applicant as prime contractor or proportionately substantially completed works means those works that 100% completed as on date. And continuing satisfactorily on the date of application for this, the Certificate from the employer shall be submitted along with the application incorporating clearly the Contract value-billing amount, date of commencement of works. Satisfactory performance of the contractor and any other relevant information should be forwarded in enclosed forms. The works completed / substantially completed during the current financial year will also be considered for counting the particular construction experience.

## **4. QUALIFYING CRITERIA OF APPLICANT**

The applicant who is not capable of meeting requirement listed below shall not be qualified for the works. Post qualification will be based on Applicants all the following minimum criteria regarding their particular experience, financial position, personnel and equipment capabilities and other relevant information as demonstrated by the Applicant's responses in the forms attached to the Letter of Application. The qualifications, capacity and resources of proposed subcontractors will not be taken into account in determining the Applicant's compliance with the qualifying criteria. The applicant to, note specifically that all information given including those in the form of various formats must be supported by certificates from respective authorities (not less than Executive Engineer or equivalent).

- a) Average Annual financial turnover during the **last 3 years** i.e. from 01/06/2023, should be at least **30.00 Lacs (Balance Sheet & C.A. Certificate should be attached)**.
- b) Experience of having successfully completed Similar nature work as per Tender Work **during last 5 years** ending last day of month previous to the one in which applications are invited should be either of the following: **(Experience certificate of Govt./Semi Govt body)**

## **Preamble to Price Schedules**

- This bidding process is Item Rate Tender for Asphalt Road Resurface for Various location in Various location in VAGHODIYA Nagarpalika, VAGHODIYA.
- The Tendered should quote in figure as well as in words the rates tendered. The amount for each item should be worked out and the requisite total given.
- The design obligation and responsibility of the bidder has been properly defined in the bid document.
- Only Price Schedule - abstract will be considered for financial evaluation of the bid and final payment of contract. While Price Schedules B shall be the basis to work out a schedule of Interim payments during construction with the successful bidder.
- The bidder shall be deemed to have allowed in his price for provision, maintenance and final removal of all temporary works of whatsoever nature required for construction including temporary bunds, diverting water, pumping, dewatering etc. for the proper execution of works. The rates shall also be deemed to include any works and setting out that may be required to be carried out for laying out of all the works involved.
- The Price Schedules are to be read in conjunction with the Conditions of Contract, the Specifications as per General Technical Specification and other sections of these bid documents and these documents are to be taken as mutually explanatory of one another.
- Prices quoted by the bidder shall be firm for the entire period of Contract without any escalation.
- The bidder shall interpret the data furnished and carry out any additional survey work, or investigation work required at his own cost.
- The prices quoted shall also include for SBC Reports, Structural Designs, the Preparing Mix design charges, steel design, materials and cube testing charges. And Materials and cube testing report is only done by GERI and Government Approved Laboratory. And testing report should be submitted **20%** from GERI and **80%** from Government Approved Laboratory.

- The bidder should acquaint himself with the site conditions including the access to Worksite. The successful bidder shall have to make suitable access to worksites at his own cost. These accesses will be used by the other contractors working for Nagarpalika.
- The rate should be quoted including of GST and all tax.
- Statutory variation if any will be on account of Nagarpalika.
- After tender accepted 2.50% Security deposit is to be paid in form of FDR/BG pledge in the name of Chief Officer, VAGHODIYA Nagarpalika from any nationalized Bank, reputed Schedule Bank, and valid for three year and 2.50% Security deposit amount will be deduct from running bills of the contractor. The 5.00% amount of security deposit will be kept up to defect liability period of 3(Three) years and 5.00% as performance bond is to be inform of FDR/BG in the name of chief officer at the time of agreement and same will be Kept up to Completion Certificate of the Work and 1% amount of running bill will be deducted from the bill as labour cess. Prices quoted by the bidder shall be firm for the entire period of Contract without any escalation. And prevailing income tax deducted from each bill and Income tax will be deducting from contractors each bill as per prevailing rate of Government.
- Nagarpalika will deploy third party inspection agency for construction supervision & inspection of material.
- Bidders should quote prices with all the taxes & duties prevailing at the time of submission of tender however statutory variation if any will be on account of Nagar seva sadan.
- The third party inspection agency will check all the measurement of the bills & only after the certificate from the third party inspection agency the R.A. bill will be process for payment.
- As per the prevailing norms of the Labour Department of Government **1%** amount of running account bill will be deducted from the bill as labour cess & same will be deposited by Nagar sevasadan to the Government.

- As per the prevailing norms of the GST Department of Government **SGST 1% & CGST 1%** Total **2%** amount of running/Final bill will be deducted from contractor each bill as per Government rules & condition. No extra charge will be given by Nagarpalika.
