

QUALIFICATIONS OF TENDERERS

Tenderer shall be required to submit the enlisted documents Online along with Scan Copy of EMD and tender fees. If documents are insufficient or it does not match the required criteria mentioned below, then the Price Bid of the tenderer shall not be opened. Tenderer shall be required to submit the original hard copy of EMD, Tender fees and all documents require for Pre-Qualification in Specified Time. Mainly tenderer shall fulfil following Criteria for pre-qualification,

1. Current Calendar Year Solvency certificate of 20% Of Tender Amount from bankers of schedule bank/nationalized bank issued must be enclosed
2. Valid Registration in Class- “D” and above or more with the Gujarat State Govt, or PWD/ CPWD department an attested copy must be enclosed. (If Bidder Applied for Renewal of Registration, Bidder must have to attach receipt of renewal fee for valid registration.)
3. Attested copy of PAN number must be enclosed.
4. Attested last 6 month's chalan copy of P.F No must be enclosed.
5. Attested last 6 month's chalan copy of GST must be enclosed.
6. Attested Copy of completion Certificate in Form 3A for the Single work of constructing similar work amounting to minimum Rs. 40% of the Tender Amount (Only Government/Semi Government / Nagarpalika/Mahanagarpalika) in last Five years must be enclosed.
7. Turnover should be at least 100% of the Tender Amount in any One year during last 5 financial years (i.e., Year 2018-19 To Year 2022-23).
8. Applicant must provide undertaking of non-blacklisting on 50 Rs Stamp Paper.
9. Site Visit Certificate on 300 Rs Stamp Paper on as is where is acceptance.
10. Any Damage to any Sewer line or water line or in any other way during the work will be the responsibility of the contractor.
11. No subletting of any kind of work or job. Agency should appoint experience engineer with minimum qualification of B.E. for routine supervision.
12. All agencies intending to carry out excavation have to carry out any type of excavation/digging only after prior intimation through “**Call before u dig**” mobile application.
13. Agency should be register under **BOCW act 1996**

In case any works are incomplete or not completed within the time limit by the contractor, the contractor will not be able to fill the tender.

Note: -

1. Joint ventures are not allowed.
2. Defect Liability Period shall be **36 MONTHS** from the certified date of completion.
3. Maintenance will be carried out by agency for **36 MONTHS** from the certified date of completion on his own Expense.
4. Any corporation registration in not valid.
5. A **watchman** shall be kept by the contractor at the site for **28 days** after completion of work.
