Demand draft issued after the last date of submission of Bids will not be considered or accepted.
6.2	Bid Security i.e. EMD: Rs.1,15,000/- (Rupees Ten Lakhs fifteen thousand only) in the form of FDR in favour of " Executive Engineer, R&B Division, Bhuj " R&B from any Nationalized / Scheduled Bank except Co-operative Bank. FDR shall be valid up to 180 Days. FDR issued after the last date of submission of tender will not be considered as valid or accepted in any case. (DD for the purpose of EMD will not be considered)

6.3	Demand Draft for Tender Fee & FDR for EMD with Registration & Solvency Documents shall be submitted in electronic format only through on line (by scanning) while uploading the bid.
