- 1.7.** The Tenderer is at liberty to bring aggregates, sand and other construction materials from approved quarries in conformity with Indian Standard specifications from any sources of his choice at his risk and cost. However the Item wise price quoted shall be inclusive of all lead and lifts for all materials required for the work.
