The interested Consultancy Firms who have experience in preparation of DPR with Transaction Advisory experience for Roads and Bridges/ Elevated structure and fulfilling technical and financial criteria as specified in RFP may obtain Request for Proposal (RFP) document from-www.eproc2.bihar.gov.in only.
7. The Applicant shall furnish as part of its Proposal, a Bid Security in the favour of Chief General Manager, Bihar State Road Development Corporation Ltd. Patna for an amount of Rs.10,00,000.00 (One Lakh Only) either online or through Bank Guarantee from any Nationalized Bank and shall remain valid till 28 days beyond the Bid validity period of 120 days. Bid Security in Original form (or, payment receipt of Bid Security in case of online payment) will have to be deposited along with Hard Bound Copy of Technical Proposal only in the office of Chief General Manager, Bihar State Road Development Corporation Ltd. Patna on or before the time and date specified above and mentioned in Data Sheet, failing which the Proposal will be rejected.
8. E-tendering processing fee, as applicable shall be paid online to BELTRON at the time of uploading of RFP.
9. For participating in E-RFP process, the applicant shall have to get them registered to get user ID Password and digital Signature. This will enable them to access the website-eproc2.bihar.gov.in and participate in e-tender. 11. Consultants can access RFP documents on the website, fill them and submit the completed RFP document into Electronic RFP on the website itself. Consultants shall attach scanned copies (PDF/JPG) of all the required RFP papers, Bank Draft, Bank Guarantee, & the certificates as required in Eligibility criteria.
12. All the uploaded documents shall have the signature of consultants or their authorized signatories. The scanned copies should be of the original papers and certificates.
13. The Consultant is requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded if they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The Consultant should satisfy themselves of Download ability and visibility of the scanned & uploaded file by them.
14. The Consultant is directed to zip their files using Win Zip or Win RAR software only. Other formats of zipping will not be accepted and will be rejected.
15. The Consultant must use MS Office-2007 or higher version.
