- **N** = Number of years prescribed for completion of the works for which tenders are invited (i.e., 12 / 12 = 1.00).
- **B** = Value of existing commitments and on-going works to be completed during the next N year (i.e., the period of completion of the works for which tenders are invited).

Note:

The statements/certificates showing the value of existing commitments and ongoing works, as well as the stipulated period of completion remaining for each of the works listed, should be signed by the respective Employer or their authorized representative, not below the rank of an Executive Engineer or equivalent.
