2. The Contractor firm should be reputed and recognized and have dealt with PGVCL or other Govt. /Semi. Govt. Dept. and must quote GST No.
3. The Materials used for work are as per specifications and approved by Eng. In Charge,
4. The Contractor must quote rates in the tender Documents only. There should not be any over writing. If any correction, it must be initial with signature of the tendered.
5. The work should be furnished within stipulated period specified in order falling which penalty at rate of 0.5% per week not exceeding 10 % of the order value will be levied
6. The Contractor should quote the rates **Inclusive of GST** , inclusive of all types of labor charges etc
7. Any variation in rates etc. Will not be allowed on any ground such as mistaken misunderstanding etc. for offer submitted also in case of divergence the rates mentioned in the words as well as figures it will be constructed to read favourable to PGVCL and that will be binding to the tendered.
8. The tendered documents must be signed where required by the tendered and must affix the rubber stamp of the firm/ Company/ individual with address.
9. No any price variation, No any ground will be considered once item wise order finalized against the rates tendered.
10. All tender offers shall be open for acceptances by the company a period of 60 days from the date of opening of tenders shall be bound to accept such acceptances.
