

1. Tenders must be invited for all works proposed to be given on contract unless the amount of works


proposed to be given on contract is Rs 50,000 or less. The N.I.T. shall be posted in public places signed by the authority inviting the tenders. N.I.T. will state the work to be carried out as well as the date for submitting and opening tenders and the time allowed for carrying out the work, also the amount of earnest money to be deposited with the tender and the amount of the security deposit to be deposited by the successful tenderer & the percentage, if any to be deducted from bills, it will also state whether a refund of quarry fees, royalties and ground rents will be granted. Copies of the specifications, designs and drawings and a schedule of items quantities and rates of the various description of work and any other documents required in connection with the work signed for the purpose of identification by the authority competent to approve the tender shall also be open for inspection by the contractor at the office of the authority selling the tender forms during office hours. Further that the schedule of items along with the quantities and rates payable shall be attached to the tender documents and in the event of variation in rates given in such list with the schedule of Rates the rates given in the S.O.R. approved by the competent authority shall prevail.

2. In the event of the tender being submitted by a firm it must be signed separately by each member thereof, in the event of the absence of any partner it must be signed on its behalf by a person holding a power of attorney authorizing him to do so, such power of attorney should be produced with the tender and it must disclose that the firm is duly registered under the Indian partnership Act.
3. Any person who submits a tender shall fill up above or below the S.O.R. specified in rule he is willing to undertake the work. Only one rate of percentage above or below the S.O.R. on all the scheduled terms shall be named. Tenders that propose any alteration in the work specified in the said N.I.T. or in the time allowed for carrying out the work or which contain any other conditions of any sort will be liable to rejection. No single tender shall include more than one work but contractors who wish to tender for two or more works shall submit a separate tender for each Tenders shall have the name and number of the work to which they refer written outside the envelope.
4. The authority receiving tenders or his duly authorized assistant will open tenders in the presence of any intending contractors who may be present at the time and will enter the amount of the several tenders in a comparative statement in a suitable form. Receipts for earnest money will be given to all tenderers except those whose tenders are rejected and whose earnest money is refunded on the day the tenders are opened.
5. The Officers competent to dispose of the tenders shall have right of rejecting all or any of the tenders **without assigning any reason thereof.**
6. The receipt of a clerk for any money paid by the contractor will not be considered as any acknowledgement of payment to the Director, UAD Raipur selling the tender form and the contractor shall be responsible for seeing that he procures a receipt signed by that authority or any other person duly authorized by him.


CONDITIONS OF CONTRACT

Definition

1. The contract means the documents, forming the notice inviting tenders and tender documents submitted by the tenderer and the acceptance thereof including the formal agreement executed between the Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)and the contractor.
2. In the contract the following expressions shall unless otherwise required by the context have the meanings hereby respectively assigned to them: -
 - (a) The expression "works" or "work" shall unless thereby mean something either in the subject or context repugnant to such construction be construed and taken to mean the works or by virtue of the contract contracted to be executed whether temporary or permanent and whether original, altered, substituted or additional.
 - (b) The "site" shall mean the land and/or other places on, into or through which work is to be executed under the contract or any adjacent land path or street through which work is to be executed under the

- (c) The "Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) means Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)his successors in Office.
- (d) The "Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) (C.G.)" means Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) Cell as the case may be who shall supervise and be in charge of the work and who shall sign the contract on behalf of theChief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)
- (e) The term "Assistant Engineer" means the Assistant Engineer DIST- (C.G.)
- (f) The word "Sub Engineer" shall mean "Sub Engineer" Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)

SECURITY DEPOSIT


- Clause 1 -** The person whose tender may be accepted (hereinafter called the contractor which expression shall unless excluded by or repugnant to the context include his heirs executors, administrators representatives and assigns) shall permit Technical Cell, DIST- (C.G.) at the time of making any payments to him for the value of work done under the contract to deduct the security deposit as under.
- The Security Deposit to be taken for the due performance of the contract under the terms & conditions printed on the tender form will be the earnest money plus a deduction of 5 (Five) percent from the payment made in the running bills.

COMPENSATION FOR DELAY


- Clause 2 -** The time allowed for carrying out the work, as entered in the tender form, shall be strictly observed by the contractor and shall be deemed to be the essence of the contract and shall be reckoned from the fifteenth day after the date on which the order to commence the work is issued to the contractor, for a work where completion is up to 6 months
- For works, for which the completion period is beyond six months: -
- The period will be reckoned from the thirtieth day after the date on which the order to commence the work is issued to contractor.
- The work shall throughout the stipulated period of contract be proceeded with all due diligence, keeping in view that time is the essence of the contract. The contractor shall be bound in all cases, in which the time allowed for any work exceeds one month, to complete 1/8th of the whole work before 1/4th of the whole time allowed under the contract has elapsed, 3/8 th of the work before 1/2 of such time has elapsed and 3/4th of the work before 3/4th of such time has elapsed. In the event of the contractor failing to comply with the above conditions, theChief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)shall levy on the contractor, as compensation an amount equal to: 0.5% (zero point five percent) of the value of work (contract sum) for each week of delay, provided that the total amount of compensation under provision of this clause shall be limited to 6% (six percent) of value of work. (Contract sum)
- Provided further that if the contractor fails to achieve 30% (thirty percent) progress in 1/2 (half) of original or validly extended period of time (reference clause 5 below) the contract shall stand terminated after due notice to the contractor and his contract finalised, with earnest money and or security deposit forfeited and levy of further compensation at the rate of 10% of the balance amount of contract left incomplete, either from the bill, and or from available security/performance guarantee or shall be recovered as "Arrears of land revenue". The decision of the Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)in the matter of grant of extension of time only (reference clause 5 below) shall be final, binding and conclusive. But he has no right to change either the rate of compensation or reduce and or condone the period of delay- once such an order is passed by him (on each extension application of the contractor)it shall not be open for a revision. Where the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)decides that the contractor is liable to pay compensation for not giving proportionate progress under this clause and the compensation is recommended during the intermediate period, such compensation shall be kept in deposit and shall be refunded if the contractor subsequently makes up the progress for the lost time, within the period of contract including extension granted, if any failing which the compensation amount shall be forfeited in favour of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)

Action when the work is left incomplete abandoned or delayed beyond the time limit permitted by the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) Clause 3:-

- (i) The Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) may terminate the contract if the contractor causes a fundamental breach of the contract.
- (ii) Fundamental breach of contract shall include, but not be limited to, the following: -

- The contractor stops work for four weeks, when no stoppage of work is shown on the current programmed or the stoppage has not been authorized by the Chief Municipal Officer,
 (b) The Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) gives notice that failure to correct a particular defect is a fundamental breach of contract and the contractor fails to correct it within reasonable period of time determined by the Chief Municipal Officer,
 (c) The contractor has delayed the completion of work by the number of weeks [12 (Twelve) weeks] for which the maximum amount of compensation of 6% of contract sum is exhausted.
 (d) If the contractor has not completed at least thirty percent of the value of construction work required to be completed in half of the completion period (Including validly extended period if any).
 (e) If the contractor fails to appoint the technical staff and if appointed do not function properly for 4 weeks even after due written notice by the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) If he violates labor laws.
 (f) If the Contractor fails to set up field laboratory with appropriate equipment's, within 30 days from the reckoned date. (* for each contract valued more than Rupees 3 crores).
 (g) Any other deficiency which goes to the root of the contract Performance
 (iii) If the contract is terminated, the contractor shall stop work immediately, make the site safe and secure and leave the site as soon as reasonably possible.
 (iv) The Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) cause recording and checking of measurements of all items of work done (taking in to account quality and quantity of items actually executed) and prepare the final bill after adjusting all pervious outstanding dues. Such recording of measurements shall be done after due notice regarding time and date of recording measurement and directing the contractor to either remain present himself or his authorized representative so as to satisfy himself that the recording of measurement is just and proper. Failure on his parts either to attend and or refusing to acknowledge the measurement so recorded in the department measurement book, shall be at his sole risk and responsibility.
 (v) In addition to the provision contained in clause 2 above the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall forfeit the earnest money and or security deposit and further recover/deduct/adjust a compensation @ 10% (ten percent) of the balance value of work left incomplete either from the bill, and or from available security/performance guarantee or shall be recovered as "Arrears of land revenue"


Power to take possession of or require removal of Materials Tools and Plants or sale of Contractor's Plants etc

Clause 4: In any case in which any of the powers, conferred upon the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) by clause - 3 hereof shall have become exercisable and the same shall not be exercised, the non-exercise thereof shall not constitute a waiver of any of the conditions hereof and such powers shall notwithstanding be exercisable in the event of any future case of default by the contractor for which by any clause or clauses hereof he is declared liable to pay compensation shall remain unaffected. In the event of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) putting in force either of the power clause 3 vested in him under the preceding clause he may, if he so desires, take possession of all or any tools, plant materials, and stores in or upon the works, or the site thereof or belonging to the contractor or procured by him and intended to be used for the execution of the work or any part thereof paying or allowing for the same in account at the contract rates, or in case of these not being applicable, at current market rates to be certified by Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) whose certificate thereof shall be final; otherwise the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) may by notice in writing to the contractor or his clerk of the works foreman or authorised agent require him to remove such tools plant, materials or stores from the premises (within a time to be specified in such notice) and in the event of the contractor failing to comply with any such requisition, the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) may remove them at the contractors expense sell them by auction or private sale on account of the contractor & at his risk in all respects and the certificate of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) as to the expense of any such removal and the amount of the proceeds and expense of any such sale shall be final and conclusive against the contractor.


EXTENSION OF TIME

Clause 5
5.1 -

If the Contractor shall desire an extension of time for completion of work on ground of his having been "UNAVOIDABLY" hindered in its execution or on any other ground, he must apply giving all and complete details of each of such hindrances or other causes in writing, to the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) positively

within 15 days of occurrence of such hindrance(s) and seek specific extension of time (period from to). In case the grounds shown by the contractor are reasonable, the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall be competent to grant the extension himself as under:-
For building work - Three months (Only for new building construction works)
For road and bridge work - One month or 10% (ten percent) of the stipulated period of completion, whichever is more.

If the extension of time sought is more than above period mentioned, then the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall refer the case to the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) with his recommendation and only after his decision in this regard, the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall sanction extension of such time as decided by the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) Once the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) has decided the case of extension of time with reference to the particular application of the contractor, it will not be competent for them to review/change such a decision later on. However, the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) and the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall give the contractor an opportunity to be heard (orally and or in writing), before taking any final decision either of granting extension of time or permitting the contractor to complete the work by the delayed date (under clause 2 of the contract) or before refusing both.

Provided further where the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) has recommended grant of extension of particular time under clause 5.1 of the contract or has refused to recommend extension of time but has recommended permitting the contractor for delayed completion, (clause 2) the contractor shall continue with the work till the final decision by referred to Superintending Engineer/Executive Engineer UAD Bilaspur.

Failure on the part of the contractor for not applying extension of time even within 30 days of the cause of such an hindrance, it shall be deemed that the contractor does not desire extension of time and that he has "Waived" his right if any, to claim extension of time for such cause of hindrance.

Once Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) has heard (oral and or in writing) the contractor on this subject matter of extension of time and if Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) fails to communicate his decision within a period of 30 days of such hearing, it shall be deemed that the contractor has been granted extension of time for the period as applied by him.


5.2 Compensation Events: - Compensation Events for consideration of extension of time without penalty.

The following mutually agreed Compensation Events unless they are caused by the contractor would be applicable;


- The Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) does not give access to a part of the site.
- Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) modifies the schedule of other contractor in a way, which affects the work of the contractor under the contract.
- The Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) orders a delay or does not issue drawings, specification or instructions /decisions/approval required for execution of works on time.
- The Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) instructs the contractor to uncover or to carry out additional tests upon work, which is then found to have no defects.
- The Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) gives an instruction for additional work required for safety or other reasons.
- The advance payment and or payment of running bills (complete in all respect) are delayed.
- The Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) unreasonably delays issuing a Certificate of Completion
- Other compensation events mentioned in contract if any.

FINAL CERTIFICATE:

Clause 6 - On completion of the work the contractor shall be furnished with a certificate by the Executive Engineer Technical cell of such completion in the form appended at the end, but no such certificate shall be given, nor shall the work be considered to be complete until the contractor

shall have removed from the premises on which the works shall be executed, all scaffolding surplus materials and rubbish, and cleaned off the dirt from all wood-work, doors windows walls, floors or other parts of any building in upon or about which the work is to be executed or of which he may have had possession for the purpose of the execution there of nor until the work; shall have been measured by the Engineer-in-charge whose measurements shall be binding and conclusive against the contractor. If the contractor shall fail to comply with the requirements of this clause as to removal of scaffolding surplus materials and rubbish and cleaning of dirt on or before the date fixed for the completion of the work, the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) may, at the expense of the contractor remove such scaffolding, surplus materials and rubbish and dispose of the same as he thinks fit and clean off such dirt as aforesaid and the contractor shall forthwith pay the amount of all expenses so incurred, and shall have no claim in respect of any such scaffolding or surplus materials as aforesaid, except for any sum actually realised by the sale thereof.

Clause 7.1 -

PAYMENT ON INTERMEDIATE CERTIFICATE TO BE REGARDED AS ADVANCES:

No payments shall ordinarily be made for work estimated to cost less than Rs. 1,000/- (Rs. One Thousand) till after the whole of the works shall have been completed and certificate of completion given but if intermediate payment during the course of execution of works is considered desirable in the interest of works, the contractor may be paid at the discretion of the Engineer-in-charge. But in the case of works estimated to cost more than rupees one thousand, the contractor shall on submitting the bill therefore be entitled to receive a monthly payment proportionate to the part thereof then approved and passed by the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) whose certificate of such approval and passing of the sum so payable shall be final and conclusive against the contractor. But all such intermediate payments shall be regarded as payments by way of advance against the final payment for works actually done and completed and shall not preclude the requiring of bad unsound and imperfect or unskillful work to be removed and taken away and reconstructed or erected or be considered as an admission of the due performance of the contract or any such part thereof, in any respect, or the accruing of any claim, nor shall it conclude determine, or affect in any way the powers of the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) under these conditions or any of them as to the final settlement and adjustment of the accounts or otherwise or in any other way vary or affect the contract. The final bill shall be submitted by the contractor within one month of the date fixed for completion of the work, otherwise the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) certificate of the measurement and of the total amount payable for work accordingly shall be final and binding on all parties.

Clause 7.2 -

Mobilization advance:-

Mobilization advance up to 5% (Five percent) of the contract value may be paid to the contractor, if requested by the contractor within one month of the date of order to commence the work. In such a case the contractor shall furnish Bank Guarantee from a schedule bank for the equal amount in favour of the CMO, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) before sanction and release of the advance. This 5% (Five percent) advance shall be payable in two stages as under.


- Stage-1:- 2% (Two percent) of the contract value payable after signing of the agreement.
- Stage-2:- 3% (Three percent) of the contract value payable on receipt of the certificate from the contractor that he has established complete central and field testing laboratories and has engaged workers/technicians and have brought requisite plants and machineries at work site, and also that the work is physically started and only after construction programme is submitted by the contractor and is duly approved by the A.E.


(ii) Recovery of Mobilization advance:-

The recovery of above advances (mobilizations, Plants and machineries shall be recovered in equal monthly installments on pro-rata basis After 15% (Fifteen percent) of contract work is executed) From each of the further running bills. However all these advances shall be fully recovered when 80% (Eighty percent) contract sum is complete or when 75% (Seventy Five percent) of stipulated or validity extended period is over - whichever event is earlier.

Clause 7.3 - Secured advance:-

Advances to contractor are as a rule prohibited, and every endeavor should be made to maintain a system, under which no payments are made for unmeasured work except for work actually done. Exceptions are, however permitted in the following cases:-
Cases in which a contractor whose contract is for finished work, requires an advance on the security of materials brought.

up to an amount not exceeding 75% of the value of material and 90% in the case of steel (as assessed by the Engineer-In-Charge) provided that the rate(s) allowed is/are in no case more than the rate payable for the finished item as stipulated in the contract of such materials, provided that they are of imperishable nature and that a formal agreement is drawn up with the contractor under which Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) secures a lien on the materials and is safeguarded against losses due to the contractor postponing the execution of the work or to the shortage or misuse of the materials, and against the expense entitled for their proper watch and safe custody.

Payment of such advances should be made only on the certificate of an officer not below the rank of A.E., that the quantities of COUNCIL materials upon which the advances are made have actually been brought to site, that the contractor has not previously received any advance on that security and that all the materials are required by the contractor for use on items of work for which rates for finished work have been agreed upon Recoveries of advances so made should not be postponed until the whole of the work entrusted to the contractor is completed. They should be made from his bills for work done as the materials are used the necessary deductions being made whenever the item of work in which they are used and are billed for. Before granting the above-secured advance the contractor shall sign the prescribed Indenture Bond in the prescribed form.

(ii) Recovery of Secured Advance:-

The recovery of above Secured advance shall be done in Three Months from date of payment of the advance, from the monthly running bills. If the advance could not be recovered during the period as mentioned above, the decision of the Engineer-in-charge in this regard shall prevail.

Bills to be submitted monthly:

Clause 8 - "A bill shall be submitted by the contractor by 15th day of each month for all works executed by him till the end of previous month less the gross amount received by him till the last previous month. This bill must be supported by records of detail measurement of quantities of all executed items of work along with true copies of record and result of all tests conducted in the previous month (date wise). The Executive Engineer shall take or cause to be taken the requisite measurement for purpose of having the same verified/checked by the Assistant Engineer and Assistant Engineer concern for quantity, quality and specification and examining all the "test results" and record the same in the Departmental measurement, book. Based on above record measurement bill shall be corrected /prepared afresh. The contractor shall sign the measurement and the bill. The Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall pay running bills by 25th day of the month subject to availability of the funds

If the contractor fails to submit, the bill on or before the day prescribed, the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) after waiting for another 15 days shall depute a subordinate to measure the said work in the presence of contractor and or his authorised Engineer/Representative, whose counter signature to the measurement recorded with quantity and quality remark will be sufficient proof for acceptance of the same and shall be binding on the contractor

All such running bill payments are by way of "Advances" and shall be subject to final adjustment.

BILLS TO BE ON PRINTED FORMS:

Clause 9 - The contractor shall submit all bills on printed forms to be had on application at the office of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) and the charges in the bills shall always be entered at the rates specified in the tender or in the case of any extra work ordered in pursuance of these conditions, and not mentioned or provided for in the tender at the rates hereinafter provided for such work.

The deduction or addition as the case may be of the percentage will be calculated on the amount of the bill for the work done, after deducting the cost of materials supplied departmentally at rates specified in the agreement.

RECEIPTS TO BE SIGNED BY PARTNERS OF PERSONS HAVING AUTHORITY TO DO SO:

Clause 10 - Receipts for payments made on account of a work when executed by a firm must also be signed by the several partners, except where the contractors are described in their tender as a firm in which case the receipt must be signed in the name of the firm by one of the partners, or by some other person having authority to give effectual receipt for the firm.

Clause 11 - Deleted

Work to be executed in Accordance with Specification, Drawing, Order, etc.:

Clause 12: The contractor shall execute the whole and every part of work in the most substantial and workman like manner, and both as regards materials and otherwise in every respect in strict accordance with the specifications. The contractor shall also conform exactly fully and

faithfully to the designs, drawings and instructions in writing relating to the work signed by the Engineer - in - charge and lodged in his office and to which the contractor shall be entitled to have access at such office or on the site of the work for the purpose of inspection during office hours and the contractor shall, if he so requires, be entitled at his own expense to take or cause to be made copies of the specifications, and of all such designs, drawings and instructions as aforesaid. MORTH/IRC specifications for road and bridges, specifications for rural roads and other I.R.C. publications and their manual, latest CPWD specifications/I.S.I. codes for buildings or special specifications whenever enclosed separately shall apply in the case of any variance the following.

Order of precedence shall prevail: -

1. Specifications as per NIT.
2. Specifications as per S.O.R.
3. MORTH/IRC specifications for road and bridges, Specifications for rural roads and other I.R.C. Publications and their manual, latest CPWD specifications/I.S.I. codes for buildings or special specifications whenever enclosed separately
4. Mode of measurements for building shall be as provided in the S.O.R. applicable to the contract. Where such mode of measurement is not specified in the S.O.R. it shall be done as per I.S.I. Code of building measurement. However if any mode of measurement is specifically mentioned in the N.I.T. the same will get precedence over all the above.

Clause 12 -A: Deleted

Variations

Clause 13 -

Additions, Alterations in Specifications and Designs.


The Engineer-in-Charge shall have power to make any alterations in, omissions from, additions to, or substitutions for, the original specifications, drawings, designs and instruction, that may appear to him to be necessary or advisable during the progress of the work, and the contractor shall be bound to carry out the work in accordance with any instruction which may be given to him in writing, signed by the Engineer-in-Charge and such alterations, omissions, additions or substitution shall not invalidate the contract and any altered, additional works, or substituted work, which the contractor may be directed to do in the manner above specified as part of the work; shall be carried out by the contractor on the same conditions in all respects on which he agreed to do the main work and at the same rates as are specified in the tender for the main work, provided the total value of all such increased or altered or substituted work **does not exceed 25% (Twenty Five percent)** of the amount put to tender inclusive of contractor percentage. If such value **exceeds 25% (Twenty Five percent)** it shall be open to the contractor either to determine the contract or apply for extension. But in no case the contractor shall be entitled to any rate other than the accepted rate.





Rates for works not in schedule of rates

If during the course of execution, where it is found necessary that certain item/items of work not provided for in the S.O.R. required to be carried out then the Engineer - in - charge shall identify such item / items including approximate quantity of the contract and ask the contractor to submit his rates in writing supported by the requisite data within a **period of 7 days**. The **Engineer - in - charge** shall obtain approval / modification of the proposed rate from the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) and communicate the same within a period of 4 weeks to the contractor, in case the contractor agrees to the above rates as fixed by the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) then they shall form a part of supplementary schedule of the contract agreement. If the contractor does not agree to the rate of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) then it shall be open for the Engineer - in - charge to get the work executed through any other agency. The contractor will not however be entitled to any compensation due to delay or hindrance or loss of profit accruing on account of this extra work executed by alternative agency. If the contractor commences non-schedule work or incur expenditure in regard thereto before the rates shall have been determined by the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) then he shall be entitled for payment for the work done as may be finally decided by the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) In the event of dispute, the decision of the Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall be final. Such a decision shall be given by the C.E. within a period of 30 (Thirty) days and it shall be open to the contractor not to continue that item further. In such an event that item shall be not executed by

other agency at such an approved rate by superintending Engineer. Contractor may either determine his contract if variations exceeds 10 (Ten) % of the Administrative approval, or may apply for extension.

Extension of time in consequence of variations

The time for the completion of work shall be extended in proportion of the variation of the work bear to the original contract work and certificate of Engineer-in-Charge shall be conclusive as to such proportion.

NO CLAIM TO ANY PAYMENT OR COMPENSATION FOR ALTERATION IN OR RESTRICTION OF WORKS:

Clause 14 -

If at any time after the execution of the contract documents, the Engineer - in - charge shall for any reason whatsoever require the whole or any part of the work as specified in the tender to be stopped for any period or shall not require the whole or part of the work to be carried out at all or to be carried out by the contractor he shall give notice in writing of the fact to the contractor who shall there upon suspend or stop the work totally or partially, as the case may be.

If any such case, except as provided hereunder, the contractor shall have no claim to any payment or compensation what so ever on account of any profit or advantage which he might have derived from the execution of the work in full, but which he did not so derive in consequence of the full amount of the work not having been carried out, or on account of any loss that he may be put to on account of materials purchased or for unemployment of labour recruited by him. He shall not also have any claim for compensation by reason of any alteration having been made in the original specifications, drawing, designs and instructions, which may involve any curtailment of the work as originally contemplated. Where, however, materials have already been purchased or agreed to be purchased by the contractor shall be paid for such materials at the rates determined by the Engineer-in-charge, provided they are not in excess of requirement and of approved quality and / or shall be compensated for the loss, if any that he may be put to, in respect of materials agreed to be purchased by him, the amount of such compensation to be determined by the Engineer-in-charge whose decision shall be final. If the contractor suffers any loss on account of his having to pay labour charges during the period during which the stoppage of work has been ordered under this clause, the contractor shall, on application be entitled to such compensation on account of labour charges as the Engineer - in - charge, whose decision shall be final, may consider reasonable provided that the contractor shall not be entitled to any compensation on account of labour charges, if in the opinion of the Engineer - in - charge, the labour could have been employed by the contractor else where for the whole or part of the period during which the stoppage of the work has been ordered as aforesaid. If the total duration of suspension of the work is more than the six months, then this suspension of the work will be considered as permanent stoppage of the work, and the contractor can determine the contract, if he so desires.

ACTION AND COMPENSATION PAYABLE IN CASE OF BAD WORK:


Clause 15 -

If at any time before the security deposit is refunded to the contractor, it shall appear to the Engineer - in - charge or his subordinate in charge of the work, that any work has been executed with unsound, imperfect or unskillful workmanship or with material of inferior quality or that any materials or articles provided by him for the execution of the work are unsound, or of a quality inferior to that contracted for, or are otherwise not in accordance with the contract, it shall be lawful for the Engineer - in - charge to intimate this fact in writing to the contractor and then notwithstanding the fact that the work, materials or articles complained of may have been inadvertently passed, certified and paid for contractor shall be bound forthwith to rectify, or remove and reconstruct the work so specified in whole or in part, as the case may require, or if so required, shall remove the materials or articles so specified and provide other proper and suitable materials or articles at his own proper charge and cost, and in the event of his failing to do so with in a period to be specified by the Engineer - in - charge in the written intimation aforesaid, the contractor shall be liable to pay compensation at the rate of one percent on the amount of contract put to tender every day not exceeding ten days, during which the failure so, continues and in the case of any such failure the Engineer - in - charge may rectify or remove and, re-execute the work or remove and replace the materials or articles complained of as the case may be at the risk and expense in all respects of the contractor. Should the Engineer-in-charge consider that any such inferior work or materials as described above may be accepted or made use of it shall be within his discretion to accept to the same at such reduced rates as he may fix therefore


WORK TO BE OPEN FOR INSPECTION-CONTRACTOR OR RESPONSIBLE AGENT TO BE PRESENT:

Clause 16 -

All work under or in course of execution or executed in pursuance of the contract shall at all time be open to the inspection and supervision of the Engineer-in-Charge and his subordinates

and the contractor shall at all time during the usual working hours, and at all other times at which reasonable notice of the intention of the Engineer-in-charge or his subordinate to visit the work shall have been given to the contractor, either himself be present to receive orders and instruction or have a responsible agent duly accredited in writing present for that purpose. Orders given to the contractor's agent shall be considered to have the same force as if they had been given to the contractor himself

NOTICE TO BE GIVEN BEFORE WORK IS COVERED UP:

Clause 17 -

The contractor shall give not less than five days notice in writing to the Engineer - in - charge or his subordinate in charge of the work before covering up or otherwise placing beyond the reach of measurement any work in order that the same may be measured, and correct dimensions thereof be taken before the same is so covered up or placed beyond the reach of measurement, any work without the consent in writing of the Engineer-in-charge or his subordinate in charge of the work and if any work shall be covered up or placed beyond the reach of measurement without such notice having been given or consent obtained, the same shall be uncovered at the contractors expenses, or in default thereof, no payment or allowance shall be made for such work or the materials with which the same was executed.

CONTRACTOR LIABLE FOR DAMAGE DONE AND FOR IMPERFECTIONS AFTER CERTIFICATE OF COMPLETION

Clause 18-

If the contractor or his work people or servants shall break, deface injure or destroy any part of building in which they may be working or any building, road, road curbs, fences, enclosures, water pipes, cables drains, electric or telephone posts or Wires trees grass or grassland or cultivated ground continuous to the premises on which the work or any part of it is being executed, or if any damage shall happen to the work while in progress, from any cause whatever, or any imperfections become apparent, the contractor shall make good the same at his own expense or in default, the Engineer - in - charge may cause the same to be made good by other workmen and deduct the expense of which certificate of the Engineer-in-charge shall be final) from any sums that may be then or at any time thereafter, may become due to the contractor or from his security deposits, or the proceeds of sale thereof or of a sufficient portion thereof.

The security deposit of the contractor to the extent of 50% shall be refunded on his getting the completion certificate, provided that all the recoveries outstanding against him are realised. Balance 50% of the amount shall be refunded after four months of completion of work or final bill paid whichever ever is earlier.


CONTRACTOR TO SUPPLY PLANT, LADDERS, SCAFFOLDING, ETC.:


Clause 19 -


The contractor shall supply at his own cost materials (except such special materials if any, as may in accordance with the contractor be supplied from the Engineer - in - charge's Stores) plants, tool, appliances, implements, ladders, cordage, tackle, Scaffolding and temporary work requisite for the proper execution the work whether original, or altered or substituted, and whether included in the specification or other documents forming part of the contractor referred to in these condition or not or which may be necessary for the purpose of satisfying or complying with the requirement of the Engineer - in - charge as to any matter as to which under these conditions he is entitled to be satisfied, or which he is entitled to require together with carriage there for to and from the work. The contractor shall also supply without charge requisite number of persons with the means and materials necessary for the purpose of setting out works, and counting, weighing & assisting in the measurement or examination at any time and from time to time of the work, or materials. Failing his so doing the same may be provided by the Engineer - in charge at the expenses of the contractor and the expenses may be deducted from any money due to the contractor under the contract, or from his security deposit or the proceeds of sale thereof, or of a sufficient portion thereof.

Contractor is liable for damages arising from non-provision of lights fencing etc. The contractor shall also provide at his own cost except when the contract specifically provides otherwise and except for payments due under clause all necessary fencing and lights required to protect the public from accident and shall be bound to bear the expenses of defence of every suit, action or proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions & to pay any damage and costs which may be awarded in any such suit, action or proceedings to any such person or which may with the consent of the contractor be paid to compromise any claim by any such person.

"The security Deposit of the contractor to the extent of 50% shall be refunded on his getting the completion certificate, provided that the recoveries outstanding against him are realized. Balance 25% of the amount shall be refunded after 4 months in case of building work and 6 months in case of road works of completion of work, even if the final bill is not passed, balance 25% shall be refunded after the final bill is passed."

COMPENSATION UNDER SECTION 12 SUB-SECTION (1) OF THE WORKMAN'S COMPENSATION ACT 1923:

Clause 20 -

In every case in which by virtue of the provisions of section 12 sub-section (1) of the workman's compensation Act 1923 Government is obliged to pay compensation to a workman employed by the contractor in execution of the works, Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) will recover from the contractor the amount of compensation so paid and without prejudice to the rights of Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) under section (1) sub-section (2) of the said Act. Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) shall be at liberty to recover the amount or any part thereof by deducting it from the security deposit or from any sum due by Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) to the contractor whether under this contract or otherwise. Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) may not be bound to contest any claim made against them under section - 12 sub-section (1) of the said Act except on the written request of the contractor and upon his giving to Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) full security for all cases for which Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) might become liable in consequence contesting such claim.

LABOUR:

Clause 21 - The contractor should get himself registered under contract - labour regulations and abolition Act 1970 including its amendments after getting a certificate from the principal employer, who will be the Engineer - in - charge.

Clause 22 - Labour below the age of 14 years - No labour below the age of 14 years shall be employed on the work.

FAIR WAGE:

Clause 23 - The contractor shall pay not less than fair wage to labour engaged by him on the work.
Explanation -

- (a) Fair wage' means wage(s) whether for time or piece work notified during the period of execution of contract for the work and where such wages have not been so notified, the wages prescribed by the Works Department SOR for that period
- (b) The contractor shall, notwithstanding the provisions of any contract to the contrary cause to be paid a fair wage to labourers indirectly engaged on the work including any labour engaged by his sub-contractors in connection with the said work, as if the labourers had been immediately employed by him.
- (c) In respect of labour directly or indirectly employed on the work for the performance of the contractors part of this agreement the contractor shall comply with or cause to be complied with the Labour Act in force.
- (d) The Executive Engineer Technical Cell shall have the right to deduct, from the moneys due to the contractor, any sum required or estimated to be required for making good the loss suffered by a worker or workers by reasons of non-fulfillment to the conditions of the contract for the benefit of the workers nonpayment of wages or deductions made from his or their wages, which are not justified by the terms of the contract or non observance of the regulations.
- (e) The contractor shall be primarily liable for all payments to be made under and for observance of the regulations afore said with out prejudice to his right to claim indemnity from his sub-contractors.
- (f) The regulations aforesaid shall be deemed to be a part of this contract and any breach thereof shall be deemed to be a breach of this contract.

Subletting of works

Clause 24 :- The contract may be rescinded and security deposit forfeited, for subletting the work beyond permissible limits as per clause 7.1 of appendix 2.10 or if contractor becomes insolvent: -

"Note: Such subletting/assignment shall not be made to any other Contractor registered in Class D to A Category in the Public Works Department of Chhattisgarh"

24.1 The contract shall not be assigned or sublet without prior sanction of the authority who has accepted the tender in writing. And if the contractor assign or sublet his contract, for more than permissible limits as per clause 7.1 of appendix 2.10 or attempt to do so, or become insolvent commence any insolvency proceedings or make any composition with his creditors, or attempt to do so or if any gratuity, gift, loan, perquisite, reward of and advantage pecuniary or otherwise, shall either directly or indirectly be given, promised or offered by the contractor, or any of his servants or agents or to any public officer or person in the employ of Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) in any way relating to his office or employment, or if any such officer or person shall become in any way directly or indirectly interested in the contract, the Executive Engineer may there upon by notice in writing rescind the contract, and the S.D. of the contractor shall there upon stand forfeited and be absolutely at the disposal of Chief Municipal Officer, Nagar Panchayat

Baramkela Dist- Sarangarh-Bilaigarh(C.G.)and the same consequences shall ensure as if the contract had been rescinded under clause 3 thereof, and in addition the contractor shall not be entitled to recover or be paid for any work thereto for actually performed under the contract. Any such assignment/subletting within the limit of 25% by the authority who has accepted the tenders OR 50 % by the next higher authority accepting the tender or Govt. as the case may be ,shall not diminish or dilute the liability/ responsibility of the contractor.If the contractor gets item / items of work executed on a task rate basis **without** materials, this shall not amount to subletting of the contract.

Any subcontracted work, done in Chhattisgarh state with prior approval of competent authority, such subcontractor will also get the credit for work towards his experience.

- i) The department shall be empowered to terminate any contract if the contractor sublets the works to some other person on the basis of power of attorney.
- ii) Subletting of work shall result in reduction in experience of the main contractor to the extent of the sublet.

Sum payable by way of Compensation to be considered as Reasonable Compensation

Without Reference to Actual Loss:

Clause 25: All sums payable by way of compensation under any of these conditions shall be considered as reasonable compensation to be applied to the use of Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) without reference to the actual loss or damage sustained, and whether or not any damage shall have been sustained.

CHANGE IN THE CONSTITUTION OF FIRM:

Clause 26 - In the case of tender by partners any change in the constitution of the firm shall be forthwith notified by the contractor to the Engineer -in-charge for his information, and contractor shall initiate steps for fresh & new registration which shall be assessed & decided by the competent authority for fresh registration

WORK TO BE UNDER DIRECTION OF EXECUTIVE ENGINEER / SUPERINTENDING ENGINEER:

Clause 27 - All works to be executed under the contract shall be executed under the direction and subject to the approval in all respect of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) of the Directorate UAD for the time being who shall be entitled to direct at what point or points and in what manner they are to commenced and from time to time carried on.


ARBITRATION CLAUSE:

Clause 28 Except as otherwise provided in this contract all question and dispute relating to the meaning of the specification, designs, drawings and instruction herein before mentioned as to thing whatsoever in any way arising out of or relating to the contract designs, drawings, specification, estimate, concerning the works, or the execution or failure to execute the same, whether arising during the progress of the work, or a after the abandonment there of shall be referred to the Superintending Engineer for his decision, within a period of 30 (thirty) days of such an occurrence (s). There upon the Superintending Engineer shall give his written instructions and/or decisions, after hearing the contractor and Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)within a period of 15 (fifteen) days of such request. This period can be extended by mutual consent of parties.Upon receipt of written instructions or decisions, of Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)the parties shall promptly proceed without delay to comply such instructions or decisions. If the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)fails to give his instruction or decisions in writing within a period of 15 (fifteen) days or mutually agreed time after being requested and/or, if the party (es) is/are aggrieved against the decision of the Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) who shall afford an opportunity to the parties of being heard and to offer evidence in support of his appeal. The, Chief Municipal Officer, Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)will give his decision within 30 (thirty) days, or such, mutually agreed period. If any party is not satisfied with the decision of the Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)he can file the petition for resolving the dispute through arbitration in the arbitration tribunal.


A reference to Arbitration Tribunal shall be no ground for not continuing the work on the part of the Contractor. Payment as per original terms and condition of the agreement shall be continued by Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)in accordance with clause 8 above.

LUMP SUM IN ESTIMATE:

Contractor's Percentage whether Applied to Net or Gross Amounts of Bills:

Clause 31 - The percentage referred to at Para 7 of the tender will be deducted from/added to the gross amount of the bills for work done after deduction of the cost of materials supplied by the department.

Claim for Quantities Entered in the Tender or Estimate:

Claim for Compensation for Delay In Starting the Work:



Clause 37 -

DEATH OF PERMANENT INVALIDITY OF CONTRACTOR:

If the contractor is an individual or a proprietary concern, partnership concern, dies during the currency of the contract or becomes permanently incapacitated, where the surviving partners are only minors the contract shall be closed without levying any damages/compensation as provided for in clause 3 of the contract agreement. However, if competent authority is satisfied about the competence of the surviving, then the competent authority shall enter into a fresh agreement for the remaining work strictly on the same terms and conditions, under which the contract was awarded.

4.2 **Powers of Officer, receiving tenders:** The officer who opens the tender and for which he is not competent to accept, shall forward the tender to the competent authority through proper administrative channel; with his definite recommendation and enclosing therein all the tenders so received along with a complete set of approved NIT.

4.3: Conditional tender are liable to be rejected

4.4 **Canvassing:** - Canvassing for support in any form for the acceptance of any tender is strictly prohibited. Any tenderer doing so will render himself liable to penalties which may include removal to of his name from the register of approved contractors or penal action under section-8 of the C.G. VinirdishttaBhrastaAcharanNivaranvidheyak, 1982.







Specifications -

5.1 Brief Specifications: - A brief note on construction and specification of all the major items of the work is enclosed in **Annexure- D**

5.2 Material of construction: - The materials of construction to be used in the work shall be governed by the MORTH /IRC specifications for Rural roads /other IRC publications and their manual/ latest CPWD specifications/ISI codes for buildings and the relevant Indian standard specification with amendments and revisions issued up to the date of tender notice. Where ever any material has I.S.I. mark such material alone has to be used

5.3 Workmanship: - The work shall be carried out according to the specification referred to hereinafter and according to sound engineering practice. The decision of the Executive Engineer, in respect of workmanship will be final.

5.4 Specification for building work:- (Including water supply and sanitary fittings.)

5.4.1 The contractor shall execute the work in conformity with the standards and procedure laid down latest CPWD specifications/ISI codes for buildings or special specification when ever enclosed separately and in accordance with the approved drawings

5.4.2 Concrete. All concrete shall be Mixed in concrete mixer and compacted by mechanical vibrators. Slump test shall be carried out during concreting and sample test cubes prepared and tested for strength in accordance with the code. The Department will carry out the testing at the cost of contractor.

The results of the tests shall conform with the required standard and if **Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)** considers that a structural test is necessary, the same shall be carried out as instructed by the **Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)** at the contractor's expense and should the result of this be unsatisfactory the contractor will be bound to take down and reconstruct the particular portion of which has given unsatisfactory test results.

5.4.3 Bricks:- The contractor should use the bricks manufactured on the metric system, as far as possible.

5.4.4 All timber used in the wood work for works must be properly seasoned. In case of important buildings mechanical seasoning should be done in good seasoning plant.

In case the contractor does not procure good seasoned wood, he may be asked to get it seasoned in plant at his own expense

5.4.5 Maintenance of roofs. Subject to the provision in the agreements, it will be the responsibility of the contract to see that the roof does not leak, during the period of the first rainy season in respect of tile and sheet roofing and two consecutive rainy seasons in respect of lime concrete and cement concrete terraced roof, after its completion. He will make good and replace all the defective work on this account at his own cost.

5.5 Specification of Electrical works.

5.5.1 The work will be carried out as per the approved drawing and as directed by the Engineer-in-charge the work will be governed by "General specifications" for the Electrical works in Government building in Chhattisgarh in forces from 1972. All electrical materials must bear "ISI mark."

5.5.2 All samples of electrical accessories should be got approved from the Engineer-in charge prior the us in work. Contractor will have to arrange and afford all facilities for their inspection and rectify the defects pointed out by them. Item involved in the Electrical work in enclosed in Annexure D.

5.5.3 The period of testing and refund of deposit will be 6 months after completion of work.

5.5.4 In case of supply of ceiling fan, table fan, exhaust fan, cabin fan tube light fixtures will be made by the department as mentioned in the SOR as such labour rates only as per SOR will be paid for fitting of such items in position as per SOR.

5.5.5 The contractor should submit "as build" detailed wiring diagram on tracing cloth showing the point position of switch length of point, position of D.B. and main switch circuit No. in which points fall at time of final bill. Otherwise deduction of ½ percent (Half percent) will be made from the contract sum of all electrical items.

5.6. Specifications for road/bridge/culvert works.

The CG road works shall be carried out according to MORST&H specifications for CG road works/ Specifications for Rural roads ,its manual / specification in force' and or special specification or the relevant specifications published by the Indian Road congress.

5.7 Contradictions or amendments: In the event of contradiction between the stipulations of the Schedule of rates (schedule of rate relevant to this NIT) and aforesaid specification (vide Para 5.1 to 5.6 above) the stipulations of the schedule of rates shall gain precedence. In the event of contradictions, if any, between different specifications and or codes of practice, referred to above the decision of Chief Engineer shall be final.





6.2 Delay in supply :-If the materials are not supplied in time the contractor will not be allowed any claim for any loss, which may be caused to him but only extension of time will be given at the discretion of the **Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)** and if applied for by the contractor with in 15 days of its proposed utilization and as detailed in the latest construction program. Request of such material by the contractor shall be sent with in one month in advance.

7. Miscellaneous Conditions

1.:The tenderer or supplier should have a place of business in the State of Chhattisgarh from where the goods would be supplied to various destination in the state and also hold a registration certificate as per rules.

2.:The tenderer or supplier shall also submit the clearance certificate as provided under section 36 of Chhattisgarh VanijyakKarAdhiniyam.

7.1 Subletting: The contractor shall not without the prior approval of the authority who has accepted the tender in writing, sublet or assign to any other party or parties, any portion of the work under the contract. Where such approval is granted, the contractor shall not be relieved of any obligation or duty or responsibility, which he undertakes under the contract. However such subletting in no case be more than 25 % of contract value. But if required can be increased up to 50(fifty) % with the prior permission of the next higher authority accepting the tender or the Government as the case may be

7.2 Taxes: The rate quoted by the Contractor shall be deemed to be inclusive of the sales and other levies, duties, royalties, cess, toll, taxes of Central and State Governments, local bodies and authorities that the Contractor will have to pay for the performance of this Contract. The Govt.will perform such duties in regard to the deduction of such taxes at source as per applicable law. However if "Service Tax" and cess on service tax or any other "New Tax" (not increase or decrease in existing tax, duties, surcharge, except royalty on minor mineral) is levied on the contractor either by Central Govt. or State Govt.

7.3 Minerals extracted for works carried out on behalf of the Government of India , from the quarries in possession of and controlled by the state Government is subject to payment of Royalty by the contractor to whom it shall not be refundable. The **Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) (C.G.)** shall not also issue any certificate in respect of such materials extracted for Government of India work (Applicable to Government of India works only)

7.4 Rules of Labour Camps: The contractor will be bound to follow the Chhattisgarh Model Rules relating to layout, water supply and sanitation on labour camps (vide Annexure-A) and the provision of the National Building Code of India work in regard to constructions and safety.

7.5 Fair Wages: The contractor shall pay not less than fair wages to labourers engaged by him during the contract period of the works (rules enclosed vide Annexure-B).

7.6 Work in the Vicinity: The **Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.) (C.G.)** reserves the right to take up departmental work or to award work on contract in the vicinity without prejudice to the terms of contract.

7.7 Best quality of construction materials. Materials of the best quality will be used as approved by the **Chief Municipal OfficerNagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)** where ever any material bears I.S.I. stamp(mark), this shall have first preference on other available accepted material(s)

7.8 Removal of undesired persons: The contractor shall on receipt of the requisition from the Executive Engineer/Chief Engineer at once remove any person(s) employed by him on the work who in the opinion of the Executive Engineer/Engineer in Charge is/are unsuitable or undesirable.

7.9 Amount due from contractor: Any amount due to the Government of Chhattisgarh/UADD/ Nagar Nigam/Nagar Palika/Nagar Panchayat from the contractor on any account concerning work may be recovered from him as arrears of land revenue.

7.10 Tools and Plants: - The contractor shall arrange at his own cost tools and plant required for the proper execution of the work. Certain plants may however be issued at the sole discretion of the Assistant Engineer/Engineer in Charge and at the approved rate to the contractor as a special case.


7.11 Right to Increase or decrease work: The Engineer-in-charge reserves the right to increase or decrease with- in the scope of work any item of the work during the currency of the contract as per Provision given in clause (13) of the conditions of contract.





Assistant Engineer/CMO is not bound to arrange for priority in getting wagons or any other materials though all possible Assistant by way of recommendation will be given if it is found necessary in his opinion, if the recommendation proves to be in-effective, the contractor shall have no claim for any compensation on that count.

7.16 The methodology and equipment, material, labour, transport to be used on the project shall be furnished by the contractor to the Engineer-in-charge well in advance of commencement of work and approval of the Engineer-in-charge obtained prior to its adoption and use.

The contractor shall give a trial run of the equipment for establishing its capability to achieve the laid down specifications and tolerance to the satisfaction of the **Chief Municipal Officer** before commencement of work, if so desired by the CMO.

All equipment provided shall be of proven efficiency and shall be operated and maintained at all time in a manner acceptable to the Chief Engineer

No equipment or personnel will be removed from site without permission of the CMO.

7.17 Work Programme and methodology of construction: The contractor shall furnish his programme of construction for execution of the work within the stipulated time and obtain the approval of the Engineer-in-Charge prior to actual commencement of work. For works costing more than 10 crores The contractor shall furnish his programmed of construction for execution of the work within the stipulated time including the time and quantity schedule of material, transport, equipment, labour etc. The contractor shall also submit a statement of "Cash Flow" (as per the format enclosed) Together with methodology construction of each item of work and obtain the approval of the Engineer-in-Charge prior to actual commencement of work.

7.18 Revised program work in case of slippage: In case of slippage from the approved work programmed at any stage, the contractor shall furnish revised programmed to make up the slippage within the stipulated time schedule and obtain the approval of the Engineer-in-Charge to the revised programmed. Such progress report shall be submitted monthly (by 5th of each month) in the prescribed format in the tender documents.

7.19 Documentation: The contractor will prepare drawing(s) of the work as constructed and will supply original with three copies to the Engineer-in-Charge who will verify and certify these drawings, finally Constructed drawing(s) shall then be prepared by the contractor and supplied in triplicate along with a microfilm in case of minor and major bridges and on tracing cloth in all other cases to the Engineer-in-Charge for record and reference purpose.

7.20: The contractor shall have to provide a ruled duplicate register at site named "Site order book". It shall be in the custody of departmental supervisory staff. The Engineer-in Charge or his authorized representative shall record their instructions in this book, which shall be noted by the contractor or his authorized representative for compliance.

7.21: If any item of work is found to be substandard but the CMO is of the opinion that the same is structurally adequate and can be accepted at the reduce rate, then in such cases, the Engineer-in-Charge shall have to submit proposals for appropriate reduction of rates supported by an analysis, in justification thereof, through a letter to the **Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaigarh(C.G.)** concerned and obtain his approval expeditiously (ordinarily within 15 days). 8. SPECIAL CONDITIONS:

8.1 Agreement:-

The contractor shall give a certificate to the effect that the graduate engineer/diploma engineer is exclusively in his employment.

(f) A graduate engineer or diploma engineer may look after more than one work in the same locality but the total value of such works under him shall not exceed Rs. 200 lakhs in the case of a graduate engineer and Rs.100 lakhs in the case of a diploma engineer.

(g) It shall not be necessary for the firm/company whose one of the partner is a graduate engineer/diploma engineer to employ another graduate engineer/diploma engineer subject to the conditions provided under 8.1.2(a) (b) and (f).

(h) The Retired Assistant engineer who is holding a diploma may be treated at par with a Graduate for the operation of the above clause.

Note:- Such Degree or Diploma engineer must be always available on works site on day to day basis and actively supervise, instruct and guide the contractor's works force and also receive instruction from the Departmental Engineers/Sub engineers.

In case the contractor fails to employ the above technical staff or fails to employ technical staff/personnel as submitted by the contractor in Pre qualification documents if prequalification is called and or the technical staff/personnel so employed are generally not available on work site and or does not receive or comply the instructions of the department engineer and or not submit the paid voucher copy of such technical staff with running bills Rs. 15000/- per month for diploma engineer and Rs. 25000/- per month for degree Engineer and Rs. 50000/- per month for project manager shall be kept in deposit while making payments. It shall be refunded to contractor after submission of paid voucher/ Bank Statement (salary deposit statement) of technical person (diploma engineer/degree Engineer/project manager as the case may be). If the Contractor fails to deploy the diploma engineer/degree Engineer/project manager as per agreement the contractor shall be informed for his such act and the engineer in charge shall deploy the diploma engineer/degree Engineer/project manager as per the requirement and they shall be paid from the deducted amount of the contractor.

MODEL RULES RELATING TO LABOUR, WATER SUPPLY AND SANITATION IN LABOUR CAMPS


Notes: These model rules are intended primarily for labour camps, which are not of a permanent nature. They lay down the minimum desirable standard, which should be adhered to standards in permanent or semi-permanent labour camps should not be obviously be lower than those for temporary camps.

1. Location:- The camp should be located in elevated and well drained ground in the locality.


2. Labour huts to be constructed for one family of 5 persons each. The layout to be shown in the prescribed sketch.

3.Hutting: The huts to be built of local material. Each hut should provide at least 20 sqm. of living space.

4.Sanitary facilities: Latrines and urinals shall be provided at least 15 meters away from the nearest quarters separately for man and women specially so marked on the following scale.

latrines- Pit provided at the rate of 10 users or two families per scat, separate urinals as required as the privy can also be used for this purpose.

5. Drinking Water - Adequate arrangement shall be made for the supply of drinking water. If practicable filtered and chlorinated supplies shall be arranged when supplies are from intermittent sources overhead storage tank shall be provided with capacity of five liters a person per day. Where the supply is to be made from a well, it shall conform to the sanitary standard laid down in the report of the Rural Sanitation Committee. The well should be at least 30 meters away from any latrine or other source of pollution. If possible, hand pump should be installed for drinking water from well. The well should be effectively disinfected once every month and the quality of water should be got tested at the public Health Institution between each work of disinfecting.

7. Bathing and Washing - Separate bathing and washing place shall be provided for men and women for every 25 persons in the camp. There shall be one gap and space of 2 sqm. for washing and bathing. Proper drainage for the wastewater should be provided.

8. Waste Disposal - (A) Dustbin shall be provided at suitable places in camp and the residents shall be directed to throw all rubbish into these dustbin. The dustbins shall be provided with cover. The contents shall be removed every day and disposed off by trenching.

9. Medical facilities

(A) Every camp where 1000 or more persons reside shall be provided with whole time Doctor and Dispensary. If there are women in the camp, a whole time nurse shall be employed.

(B) Every camp where less than 1000 but more than 250 persons reside shall be provided with Dispensary and a part time Nurse/Midwife.

(C) If there are less than 250 persons in any camp a First Aid Kit shall be maintained in-charge of whole time persons, trained in First Aid.

All the medical facilities mentioned above shall be for all residents in the camp including a dependent of the worker, if any free of cost.

Sanitary Staff - For each labour camp, there shall be qualified Sanitary Inspector and Sweeper should be provided in the following scales:

(1) For camps with strength over 200 but not exceeding 500 persons. One sweeper for every 75 persons above the first 200 for which 3 sweepers shall be provided.

(2) For camps with strength over 500 persons one sweeper for every 100 persons above 1 st 500 for which 6 sweepers should be provided.

ANNEXURE - "B"

CONTRACTOR'S LABOUR REGULATIONS

The Contractor shall pay not less than fair wages to labourers engaged by him in the work.

Explanation

(a) "Fair Wages" means wages whether for time or piece works as notified during the period of execution of the works and where such wages have not been so notified the wages prescribed by the department in which the work is done.

(b) The contractor shall not with standing the provision of any contract to the contrary, cause to be paid a fair wage to labourers indirectly engaged on the work i/e any labour engaged by his subcontractors in connection with the said work as if labourers had been immediately employed by him.

(c) In respect of all labour directly or indirectly employed on the works or the performance of his contract, the contractor shall comply with or cause to be complied with the Labour Act, in force.


(d) The **Chief Municipal Officer Nagar Panchayat Baramkela Dist- Sarangarh-Bilaspur(C.G.)** shall have the right to deduct from the money due to the contractor any sum required or estimated to be required for making good the loss suffered by a worker or workers by reason of non-fulfillment of the conditions of the contract for the benefit of the workers nonpayment of wages or of deductions made from his or their wages which are not justified by their terms of contract on non observance of regulations.




(f) The regulations aforesaid shall be deemed to be a part of this contract and any breach there of shall be deemed to be a breach of this contract.

NOWHEREFORE, the BUYER and the BIDDER agree to enter into this pre- contract agreement, hereinafter referred to as Integrity Pact, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the contract to be entered into with a view to:-

- 2.1 Enabling the BUYER to obtain the desired Stores/ Equipment/ Work/ Service at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and
- 2.2 Enabling BIDDERS to abstain from bribing or indulging in any corrupt practices in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing any corrupt practices and the BUYER will commit to prevent corruption, in any form, by its officials by following transparent procedures.

3. COMMITMENTS OF THE BUYER

The BUYER Commits itself to the following:


- 3.1 The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the Contract.
- 3.2 The BUYER will, during the pre-contract stage, treat BIDDERS alike, and will provide to all BIDDERS the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS.
- 3.3 All the officials of the BUYER will report to the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

In case of any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the BUYER with the full and verifiable facts and the same is *prima facie* found to be correct by the BUYER, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the BUYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the BUYER the proceedings under the contract would not be stalled.

4. COMMITMENTS OF BIDDERS


The BIDDER commits himself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commits itself to the following:

- 4.1 The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the BUYER, connected directly or indirectly with the bidding process, or to any person, organization or third



party related to the contract in exchange for any advantage in bidding, evaluation, contracting and implementation of the Contract.

4. 2. The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the BUYER or otherwise in procuring the Contract of forbearing to do or having done any act in relation to the obtaining or execution of the Contract or any other Contract with the Government for showing or forbearing to show favour or disfavour to any person in relation to the Contract or any other Contract with the Government.
4. 3. The BIDDER further confirms and declares to the BUYER that the BIDDER is the original Manufacturer/Integrator/Authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the BUYER or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.
4. 4. The BIDDER, either while presenting the bid or during pre- contract negotiations or before signing the contract, shall disclose any payment he has made, is committed to or intends to make to officials of the BUYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
4. 5. The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
4. 6. The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
4. 7. The BIDDER shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the BUYER as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
4. 8. The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
4. 9. The BIDDER shall not instigate or cause to instigate any third person to commit any of the acts mentioned above.


5. PREVIOUS TRANSGRESSION

5. 1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify BIDDER's exclusion from the tender process.
5. 2 If the BIDDER makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

EARNEST MONEY/SECURITY DEPOSIT

6.1 Every BIDDER, while submitting commercial bid, shall deposit an amount as specified in the RFP as Earnest Money/Security Deposit, with the BUYER through any of the following instruments:-

- i. Bank Draft or a Pay Order in favour of the
- ii. A confirmed guarantee by an Indian Nationalized Bank, promising payment of the guaranteed sum to the(BUYER),..... on demand within three working days without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the BUYER shall be treated as conclusive proof for payment.
- iii. Any other mode or through any other instrument (to be specified in the RFP).

6.2 The Earnest Money/Security Deposit shall be valid upto a period of five years or the complete conclusion of the contractual obligations to complete satisfaction of both the BIDDER and BUYER, including warranty period ,whichever is later.


6.3 In the case of successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provisions of Sanctions for Violation shall be applicable for forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this pact.

6.4 No interest shall be payable by the BUYER to the BIDDER on Earnest Money/Security Deposit for the period of its currency.

7. SANCTIONS FOR VIOLATION


7.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the following actions, wherever required:

- (i) To immediately call off the pre-contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- (ii) To forfeit either fully or partially the Earnest Money Deposit (in Pre- Contract stage) and/or Security Deposit/Performance Bond (after the contract is signed), as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.
- (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- (iv) To recover all sums already paid by the BUYER, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the BUYER in connection with any other contract such outstanding payment could also be utilized to recover the aforesaid sum and interest.
- (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- (vi) To cancel all or any other Contracts with the BIDDER and the BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from

- such cancellation/ rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- (vii) To debar the BIDDER from participating in future Bidding processes of the Government of Chhattisgarh for a minimum period of five years, which may be further extended at the discretion of the BUYER.
- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the BUYER with the BIDDER, the same shall not be opened.
- (x) If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, either directly or indirectly, is closely related to any of the officers of the BUYER, or alternatively, if any close relative of an officer of the BUYER has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filing of tender. Any failure to disclose the interest involved shall entitle the BUYER to rescind the contract without payment of any compensation to the BIDDER.

The term 'close relative' for this purpose would mean spouse whether residing with the Government servant or not, but not include a spouse separated from the Government servant by a decree or order of a competent court; son or daughter or step son or step daughter and wholly dependent upon Government servant, but does not include a child or step child who is no longer in any way dependent upon the Government servant or of whose custody the Government servant has been deprived of by or under any law; any other person related, whether by blood or marriage, to the Government servant or to the Government servant's wife or husband and wholly dependent upon Government servant.

- (xi) The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the BUYER, and if he does so, the BUYER shall be entitled forthwith to rescind the contract and all other contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.

- 7.2) The decision of the BUYER to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Monitor(s) appointed for the purposes of this Pact.


8. FALL CLAUSE


8. 1. The BIDDER undertakes that if has not supplied/is not supplying similar products/ systems or subsystems at a price lower than that offered in the present bid in respect of any other Department of the Government of Chhattisgarh or PSU and if it is found at any stage that similar products/ system or sub-system was supplied by the BIDDER to any other Department of the Government of Chhattisgarh or a PSU at a lower price, then that very price, with due allowances for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded.


9. INDEPENDENT MONITORS

9. 1. The BUYER will appoint Independent Monitors (hereinafter referred to as Monitors) for this Pact.

9. 2. The task of the Monitors shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact.

- 9.3. The Monitors shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.
- 9.4. Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.
- 9.5. As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the BUYER.
- 9.6. The Monitor will submit a written report to the designated Authority of BUYER/Secretary in the Department/ within 8 to 10 weeks from the date of reference or intimation to him by the BUYER/BIDDER and, should the occasion arise, submit proposals for correcting problematic situations.

10. FACILITATION OF INVESTIGATION

In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information of the relevant documents and shall extend all possible help for the purpose of such examination.

11. LAW AND PLACE OF JURISDICTION

This Pact is subject to Indian Law, The place of performance and jurisdiction shall be the seat of the BUYER.

12. OTHER LEGAL ACTIONS

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the any other law in force relating to any civil or criminal proceedings.

13. VALIDITY

13.1 The validity of this Integrity Pact shall be from date of its signing and extend up to 5 years or the complete execution of the contract to the satisfaction of both the BUYER and the BIDDER/Seller, whichever is later. In case BIDDER is unsuccessful, this integrity Pact shall expire after six months from the date of the signing of the contract.

13.2 If one or several provisions of this Pact turn out to be invalid, the remainder of this Pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.





CENTRALISED PROCEDURES OF THE GOVERNMENT OF CHHATTISGARH FOR SUSPENSION, DEMOTION, NON-RENEWAL & DE-REGISTRATION OF CONTRACTORS/FIRMS, 2014

- To Replace Appendix-I to 4 of PWD Orders No. F5-8/19/2013/Nivida dated 5.8.2013
- RFP to specifically refer to the aforesaid orders as amended

1. Nomenclature and Coming into Force

1.1 These Procedures shall be called "Centralized Procedures of the Government of Chhattisgarh for Suspension, Demotion, Non-Renewal and De-Registration of Contractors/Firms, 2014".

1.2 These Procedures shall come into force with effect from the date of consequential changes made to previous orders PWD No. F5-8/19/2013/Nivida dated 5.8.2013 on the subject.

2. Scope of Procedures

2.1 These Procedures lay down substantive and procedural aspects for demotion, non-renewal and de-registration (including suspension) of registered contractors/firms, including the consequences of such demotion, non-renewal, de-registration and suspension, in relation to contracts covered by these procedures.

2.2 These procedures shall apply to all contracts awarded by state agencies participating in the unified registration system, for e-registration through the website of the state public works department, and the said participating agencies shall include their constituent, attached and subordinate offices, whether referred to as a "Department", "Wing", "Organization", "Board" or similar nomenclature in common usage.

2.3 For the purposes of these procedures, "contracts" shall mean contracts or agreements under the works department manual entered into by the state agencies to which these procedures are applicable (hereinafter referred to as "state agencies")


2.4 These procedures shall not apply to debarment and suspension (or blacklisting, banning etc., by whatever name called) by states public sector enterprises, registered societies, autonomous institutes or similar separate legal entities, even if functioning under the administrative control of the Government of Chhattisgarh.

2.5 These procedures shall be incorporated by specific reference in contracts entered into by relevant agencies with from the date of notification of these procedures. All prior contracts (i.e. cases where the last date of filling a proposal, tender, quotation, bid etc. by whatever name called, predates the date of notification of these procedures, including contracts entered into before the date of notification of these procedures), shall however continue to be governed by the specific clauses of contract and instructions issued by the government of Chhattisgarh in force prior to notification of these procedures. For cases where the last date of filling a proposal, tender, quotation, bid etc., by whatever name called has already been scheduled and notification, and is subsequent to the date of notification of these procedures, an addendum to the request for proposal (or Notice Inviting Tender, request for quotation, Invitation To Bid etc. by whatever name called) shall be issued by procuring officials, to ensure that acceptance of the terms and conditions prescribed under these procedures is obtained from all participating bidders.

2.6 "Entities" shall include individuals, as well as companies, trusts, societies or other associations of individuals with whom the state agencies have entered into contracts, or intend to enter into contracts, or could enter into contracts.


3. Cross-Debarment

3.1 Any order for demotion, non-renewal, suspension or de-registration issued by the designed Authority provided for under these Procedures shall have immediate effect as provided for under these Procedures shall have immediate effect as provided for under

- these Procedures shall have immediate effect as provided herein on on contracts awarded and processed by the state agencies.
- 3.2 Any order for suspension, banning, demotion, blacklisting, de-registration or debarment issued by any authority in the Government of India or other State Government, or by any other entity not covered under the scope of these Procedures, shall not affect the eligibility of contractors or firms participation in the Unified Registration system. Unless the Designated Authority under these Procedures has issued its own order of suspension, non-renewal, demotion or de-registration, pursuant to or consequent or based upon the order issued by such an external agency, after satisfying itself that the order of suspension, non-renewal, demotion or de-registration against such a contractor/firm is appropriate and warranted in order to protect government or public interest in the facts and circumstances of the specific case.

4. Satisfaction of Designated Authority


- 4.1 Proceedings for suspension, demotion, or de-registration shall be in the nature of summary administrative decisions by the Designated Authority, aimed at protecting government of public interest.
- 4.2 Accordingly, the Designated Authority shall exercise due diligence normally expected of an administrative action for issue of an order of suspension, non-renewal, demotion or de-registration against a contractor/firm is appropriate and warranted in order to protect government of public interest in the facts and circumstances of the specific case.

5. Designated Authorities

- 5.1 The authority competent to issue and order of suspension non-renewal demotion or de-registration, including a notice or proposed demotion or de-registration shall be the authority so specified in the unified Registration system.
- 5.2 The orders of the Designated Authority shall have effect across contracts awarded and processed by the state agencies.
- 1.3 The Designated Authority shall perform his/her function independently of any superior officers, Board, Council or Committees in the Government. Normally therefore, there should not be any separate of prior requirement of bringing any case for proposed suspension, no-renewal, demotion or deregistration before any committee by any state agency, the Designated Authority shall recuse himself/herself from the deliberations or decisions of such board etc. in order to maintain his/her independence in decision making.
- 1.4 The Designate Authority shall be free and be empowered to consult any appropriate Department that he/she may deem appropriate (such as legal or finance divisions or departments) before arriving at a decision for suspension non-renewal, demotion or de-registration, However the advice, recommendation or comments of any such Department shall neither be binding upon the designated Authority and nor shall it form the sole basis of the decision of the Designated Authority.
- 5.5 To the extent practicable the designated Authority shall decide upon a case within thirty days of the proposal being submitted to it for de-registration, non-renewal, suspension or demotion, provided he/she has received all documents that he/she deems relevant.


6. Appeals

- 6.1 Appeals against orders of suspension and final orders for demotion, non-renewal or de-registration issued by the designated Authority shall lie only with the Appellate Authority specified in the Unified Registration system. The Appellate Authority shall discharge his/her functions independently of any superior officers, Boards, Councils or Committees in the Government. No appeals shall lie against a notice of proposed demotion, non-renewal or de-registration.
- 6.2 Therefore, normally there should not be any separate or prior requirement of bringing any case for proposed suspension, non-renewal, demotion or de-registration before any Board, Council or Committee. However, if any case is brought before any Board, Council or Committee, any member of the Appellate Authority represented on such

- boards etc shall recuse himself/herself from the deliberations or decisions of such Board etc in order to maintain his/her independence in decision-making.
- 6.3 The Appellate Authority shall be free and be empowered to consult any Department that it deems appropriate (such as legal or finance divisions or Department) before deciding an appeal. However, the advice, recommendation or comments of any such Department shall neither be binding upon the Appellate Authority and nor shall it form the sole basis of the decision taken in appeal by the Appellate Authority.
- 6.4 The order of suspension, non-renewal, demotion or de-registration (including notice of proposed demotion or de-registration) of the Designated Authority, or the orders in appeal issued by the Appellate Authority, shall not form part of the scope of issued that can be brought before arbitrator(s) or arbitral tribunal, notwithstanding anything contained in an arbitration agreement in relation to Authority or the Appellate Authority shall not form part of the scope of issues that can be referred to the Independent External Monitor under any "Integrity Pact" signed by covered entities under these procedures, notwithstanding anything contained in the Integrity Pact.
- 6.5 To the extent practicable, the Appellate Authority shall decide an appeal within thirty days of the appeal being submitted to it against de-registration, non- renewal suspension or demotion. Provided he/she has received all documents that he/she deems relevant from the appellant and from respondents.
- 6.6 The Appellate Authority shall have the power to pend the processing of a contract for reasons it may deem fit.
- 7. Grounds for Demotion, Non –Renewal and De-Registration**
- 7.1 The Designated, Authority may de-register a contractor/firm (referred herein below as "entity") for any sufficient reason, including any one or more of but not limited to the grounds listed below;
- (i) Conviction for, or the commencement of an investigation under the criminal Procedure code, 1973 or the filing of a chargesheet by an investigative agency in a criminal court of competent jurisdiction, or a civil judgment in respect of commission or alleged commission of fraud or an offence under any law in force in India or elsewhere, either directly or indirectly, by an entity, its proprietor, employee, partner, agent or representative in connection with (a) obtaining, or (b) attempting to obtain, or (c) performing a government contract or agreement: Provided that in case of commencement of criminal investigation this clauses shall constitute a valid ground for de-registration only if the said fraud or offence is in relation to a contract or agreement entered into with agent representative or any other intermediary in relation to any contract to which these procedures apply;
- (l) Engagement of any individual or entity to intercede, facilitates, or recommends the award of a contract, excluding legal representatives employed directly by the entity;
- (m) Collusion to impair transparency, fairness or progress of the contracting process;
- (n) Complaining without full and verifiable facts; or
- (o) Instigating or causing any third person to commit any of the above.
- 7.3 A designated Authority may not renew the registration of a contractor/ firm for any sufficient reason, including any one or more of, but not limited to, the grounds listed below:
- (i) Failure to meet any volume of work criterion specified from time to time under the unified registration system as published on the website for the system, for the particular class of registration for the last three financial years ending with the financial year immediately prior to the date of submission of proposal for non-renewal to the Designated Authority; and
- (ii) Any of the grounds specified in paragraphs 7.1 or 7.2 above.

8. Grounds for Suspension

- 8.1 Suspension of an entity can be ordered by the Designated Authority, where it determines that continuation of dealing is not considered desirable in government or public interest, pending completion of proceeding into allegation or facts related


to any of the grounds enumerated in paragraphs 7.1 and 7.2 above, and where it is considered necessary to forthwith order such discontinuation without prior notice of suspension to the entity.

- 8.2 In all such cases of suspension it shall be incumbent upon the Designated Authority to put the suspended entity on notice and to grant an early opportunity of post-decisional hearing.
9. **Effect of Suspension, Non-renewal, De-Registration and Demotion**
- 9.1 A final order of de-registration or non-renewal in respect of a contractor/firm shall result in immediate ineligibility of the contractor/firm and its affiliates for all classes of contracts (or for classes of contracts higher than the resultant demoted class in cases of demotion) from participating in future bid or contracts or agreements for a minimum period of two years and a maximum period of ten years with effect from the date of demotion or non-renewal or de-registration, including ineligibility from evaluation in ongoing cases where a contract or agreement is yet to be finally signed such ineligibility shall be without compensation from or liability to the state agency similarly, a de-registration or non-renewal contractor/firm and its affiliates shall be ineligible for award of a contract, including receipt of an order under a rate contract, and for entering into any contract covered by these procedures, in cases where an order for de-registration or non-renewal has come into effect before the signing of such contract.
- 9.2 Where the de-registration, non-renewed, demoted or suspended contractor/firm has already emerged as the most preferred bidder using price and/or technical criteria as specified in the request for proposal (or Notice Inviting Tender or Invitation To Bid or request for Quotation by whatever name called), the procurement process shall be continued beating the de-registered, suspended demoted or non-renewed contractor/firm as ineligible, notwithstanding any appeal, unless the appellate authority has pended the procurement process.
- 9.3 A de-registration or non-renewed contractor/firm shall not be eligible to receive Request for proposal (on Notice Inviting Tender or Invitation to Bid or Request for Quotation etc. by whatever name called) from the state agencies in cases of limited and/or restricted tendering where such issue is provided for under tender procedures.
- 9.4 In any case where the entity is suspended, de-registered, non-renewed or demoted subsequent to such issue, it shall not be considered eligible for the purposes of any technical, field or commercial evolution or for award or signing of contract undertaken in pursuance to the Request for proposal (or Notice Inviting Tender or Request for Quotation or Invitation To Bid etc. by whatever name called).
- 9.5 Mere initiation of a criminal or other investigation or inquiry by any authority in the Government of India or other state Governments, or by any other entity not covered under the scope of these procedures or the mere filling of a charge sheet or any other formal proceeding against an entity by an enforcement agency exercising power of a court, shall not render a contractor/firm ineligible/ unless the designated authority under these procedures has issued its own order of suspension, non-renewal demotion or de-registration, pursuant to or consequent or based upon the order issued by such an external agency, after satisfying itself that the order of suspension, non-renewal, demotion or de-registration against such a contractor/firm is appropriate and warranted in order to protect government or public interest in the facts and circumstances of the case, similarly, a notice of proposed demotion or de-registration shall not render a contractor/firm ineligible, unless a final order for demotion, non-renewal has been issued by the Designated Authority under these procedures prior to conclusion of the contract.
- 9.6 The above consequences on ineligibility of a contractor/firm shall be in addition to any criminal liability that may arise out of any laws in force in India, and also in addition to any other pecuniary consequences and civil liabilities, including penalties, costs or liabilities as may be imposed by procuring officials, as well as forfeiture of Earnest Money Deposits, encashment of bank guarantees and

performance bonds, risk and cost purchase, recovery of certain sums from the erring entity, and liability for compensation for losses or damages as may be provided for under contract or agreement, as may be provided for in the relevant Notice Inviting Tender, Request For Proposal Request For Quotation, Invitation to Bid and any such documents.

- 9.7 Notwithstanding anything contained in the contract, procuring officers shall not renew, expand or extend current contracts with suspended their duration or modify them to the advantage of a contractor/firm, unless prior approval of the authority one level above the authority competent to approve the same under the contract is taken for such renewal, modification or extension:

Provided further that in respect of de-registered contractors/firms, the level of prior approval shall be the state Government.

- 9.8 Termination of contracts, if considered appropriate by procuring officials, shall follow procedures as provided for under the contract and other relevant instructions of the Government.

10. Notice of Proposal for demotion of De-Registration (and Order of Suspension or non-Renewal)

- 10.1 Demotion of de-registration shall be initiated by the Designated Authority upon receipt of information or proposal by putting a contractor/firm on notice:

- (i) That demotion or de-registration is being contemplated;
- (ii) Of the reason for proposed demotion or de-registration relied upon under paragraph 7 of these Procedures for the proposed demotion or de-registration;
- (iii) Stating the period of demotion of de-registration and the proposed start and end dates for the period of demotion and de-registration;
- (iv) That, within fifteen days of receipt of the notice, the contractor /firm may information and arguments in connection contesting the proposed demotion/de-registration.

- 10.2 An order for suspension or non-renewal by the Designated Authority shall afford an opportunity for a post - decisional hearing to the suspended contractor/ firm. including therein:

- (i) The fact that suspension had been ordered forthwith;
- (ii) Of the reasons for suspension or non-renewal- relied upon under paragraph 7 read with paragraph 8 of these procedures;
- (iii) Stating the period of suspension or non-renewal with proposed effective end dates;
- (iv) Advising that suspension or non-renewal is effective only in respect of state agencies
- (v) That, within fifteen days of receipt of the notice, the entity may submit in writing, either in person or through a representative, information and arguments in connection contesting the suspension or non-renewal.

11. Final Order for Demotion/De-Registration

- 11.1 if the Designated Authority decides to issue a final order of demotion or de-registration, whether after the issue of an initial order of suspension or non-renewal or otherwise after issue of notice of proposed demotion or de-registration, the contractor/firm concerned shall expeditiously be given notice of such final order.

(i) Referring to the notice(s) of the order of suspension or non-renewal, if any and notice of proposed demotion or de-registration.


(ii) Specifying the reason for demotion or de-registration; and

(iii) Stating the period of demotion or de-registration including effective start and end dates.

- 1.2 if pursuant to the notice of demotion or de-registration, final orders of demotion or de-registration are not imposed, the Designated Authority shall promptly notify the contractor/firm by speed post or by registered post (acknowledgment due), in addition to the manner of publication specified under these procedures.


- 11.3 Upon completion of the period of de-registration or demotion, a de-registration contractor/firm that has been de-registration or demoted, as well as a contractor/firm whose registration has not been renewed under these.
