3. In order to participate in the tenders floated using the e-Procurement System, all contractors/bidders/supplier are required to get enrolled on the e-Procurement portal (<https://eproc.cgstate.gov.in>)
 4. The bids submitted online should be signed electronically with a Digital Certificate to establish the identity of the bidder bidding online. For submitting the bids online, the contractors/bidders are required to make online payment using the electronic payments gateway service Bid Hash Submission Fee as mentioned above The different modes of electronic payments accepted on the e-Procurement System is available and can be viewed online on the e-Procurement Website (<https://eproc.cgstate.gov.in>).
 6. Conditions related to e-Procurement are furnished in Guideline to Bidder_EPS_v1.2 for New E-procurement Website of tender document and will overrule other conditions wherever applicable/relevant.
 7. The Bidder may refer Help Manual available online to perform their online activities.
 8. The Commissioner, Municipal Corporation Bilaspur Reserves the right to reject any part of/whole tender without assigning any reason and to restrict the list of pre-qualified tenderer to any number deemed fit by him.
 9. Before the deadline for submission of tender, the Commissioner, Bilaspur Municipal Corporation modify tender document by issuing amendment. (Any amendment thus issued shall be part of the tender and shall be published on web site)
 10. "Additional performance shall be deposited by the successful bidder at the time of signing of agreement when the bid amount is seriously unbalanced. i.e. less than the estimated cost by more than 10% to 20% in such an event the successful bidder will deposit the additional performance security to the extent of differential cost of bid amount and 90% of the estimated cost in shape of Bank Guarantee issued by approved scheduled bank for agreement period in favor of Commissioner Municipal Officer in Additional To EMD failing which the tender in this favor shall be liable for Rejection." The same shall be released along with the normal S.D. After Completion of Work. If the contractor fails to complete the work or left the work incomplete, this Additional Performance Security (APS), shall be forfeited by the department & the agreement shall be terminated and action shall be taken in accordance with clause 3 of the agreement. In case the tenderer/contractor refused to deposit Additional Performance Security (APS) then his bid will be rejected by the sanctioning authority and earnest money shall be forfeited.
 11. Any amendment thus issued shall be part of the tender document and shall be published on web site.
 12. If the any document as required will not received as per desired then Tenderer will be treated not qualified and tender will not opened.




13. Contractor should submit clear and readable copy of valid labor license to concerned Executive Engineer Before commencement of the work.

14. Contractor should appoint the Engineer for supervision of work and also submit clear and readable attested copy of appointment order and consent including educational certificate of Civil/Electrical Engineer to concerned Executive Engineer Before commencement of the work.

15. Other Details can be seen in the tender documents.

16. SPECIAL CONDITION-

- A. In the event of withdrawing his/her after before the expiry of the period of validity of offer or failing to execute the agreement as required by conditions of the notice inviting tender (N.I.T.) he/she will not be entitled to tender for this work in case of recall of tenders. In addition to forfeiture of his/her earnest money as per provisions of tender condition as may be applicable for the work, the Commissioner, Bilaspur Municipal Corporation will restricted the contractor/firm for a period of one year in participation of all BMC tenders. If the Tender has committed a similar default after restriction period on earlier occasion(s) as well, then Commissioner, Bilaspur Municipal Corporation recommended for demotion in registration to the committee of 'Unified Registration System' (e-Registration) with Chhattisgarh P.W.D. State Governments will be permanently. This special condition will supersede any thing contrary to it in the tender document.
- B. Contractors are advised to go through the Notice Inviting tenders & the tender/P.Q./Bid Capacity document thoroughly Certificates, annexure, enclosures as mentioned in the document will have to be submitted by the tenders strictly in the prescribed format, at the time of submission of Technical/Financial bid, failing which the contractor shall disqualify for the work & his financial offer shall not be opened and no representation, appeal or objection, what so ever in this regard shall be entertained by the department.
- C. After the construction of B.T. Road/Building/Bridges a period of 05 Year's Shall Be Kept as Performance guarantee period as per deputy secretary PWD dept. C.G. Gov. vide order no. 21-5/T/19/2012 Tender Nava Raipur Atal Nagar Dated 20-01-2023 as enclosed with NIT.
- D. Escalation mentioned in clause 11 of tender form A will not be applicable for this tender.
- E. Financial Offer Should be Submitted Including all Taxes.
- F. In case a bidder has not filed ITR for any financial year for which the statutory due date has already expired, such bidder shall not be eligible, and submission of Declaration/Affidavite in lieu of ITR shall not be accepted.
- G. However, In case of Firms whose date of registration falls in the immediately preceding financial year or the current financial year as on the date of invitation of tender, and for whom fillin of ITR for earlir financial years was not applicable under the Income Tax Act, submission of Declaration/Affidavite Shall be permitted.

B = Value of existing commitments and on-going works to be executed during the next years * (period of completion of the works for which bids are invited) (As per Annexure-2)

Note : The statements showing the value of existing commitments and on-going works, as well as the stipulated period of completion remaining, for each of the works so listed should be countersigned by the Engineer-in-charge, not below the rank of an Executive Engineer or equivalent.

The bidder shall have to submit an affidavit (Annexure 3) that all the information furnished is correct in all respects.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have made misleading, incorrect or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements.
