##### 1.1 Object of the Project

Bids not covering the entire scope will be treated as **non-responsive** and will be liable for rejection.

#### **1.4 Time for completion:**

The time for completion of the construction of pressure irrigation network including time required for creation of construction facilities and infrastructure works, necessary pre-construction survey, investigation, soil exploration, design and drawings for the structures etc., **shall not exceed 11 Months** including rainy seasons from the date of signing of contract agreement. #### **3.0 Eligible Bidder**

3.1 This Invitation of Tender is open to all following Tenderers, who are registered with C.G..PWD Raipur under Centralized E-Registration system. However, such bidders who are not registered with

the Government of Chhattisgarh and are eligible for registration can also submit their bids after having applied for registration with appropriate authority.

- (a) Individual Person
- (b) Proprietary firm
- (c) Partnership firm
- (d) Limited company or limited corporation
- (e) Government Undertaking / Enterprises
- (f) Joint Venture or consortium of two or more firms / companies from (a) to (e) a)

A tenderer (including all members of a joint venture and all sub-contractors of a tenderer) should not be affiliated with a firm or entity which has provided consulting services during the preparatory stages of the Works or of the System of which the works form a part.

3.2 A Bidder shall not have a conflict of interest. All Bidders found to be conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest with one or more parties of the bidding parties in the bidding process, if they:

- a) have controlling shareholders in common; or
- b) receive or have received any direct or indirect subsidy from any one of them: or
- c) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, that influence the decisions of the WRD regarding the bidding process.

3.3 Government-owned / undertaking enterprises in India shall be eligible if they are legally and financially autonomous and operate under commercial law.

3.4 Bidders shall provide such evidence of their continued eligibility up to the satisfaction of the WRD, as the WRD shall reasonably require.

#### **4.0 Instruction to Applicants**

4.1 If an individual makes the application, it shall be signed by the individual above his full name and current address.

4.2 If proprietary firm makes the application, it shall be signed by the proprietor above his full name of his firm with current address.

4.3 If the application is made by a firm in partnership it shall be signed by all the partners of the firm, above their full type written names and current addresses or by a partner holding valid power of attorney for signing the application in which case a certified copy of the power of attorney shall be

enclosed with the application. A certified copy of the partnership deed, current address of all the partners of the firm shall also be enclosed with the application.

- 4.4 If the application is made by a limited company or a limited corporation it shall be signed by a duly authorized person holding the power of attorney of signing the application in which case a certified copy of the power of attorney shall be enclosed with the application. Such limited company or corporation may be required to furnish satisfactory evidence of his existence before the pre-qualification is awarded.
- 4.5 In case of J.V. following conditions and requirements must be fulfilled –
- 4.5.1 Bids submitted by a joint venture<sup>1</sup> of two or more firms as partners shall comply with the following requirements :

1. *Joint Venture is an arrangement in which two or more parties undergo an agreement for the purpose of executing a specific task/project and all parties shall be jointly and severally responsible to incur all the liabilities under that task/project, if awarded.*
2. *Partner in charge - i.e. Lead Partner.*
3. *This agreement shall also mention the NIT No./System I.D., Name of work, Name of Joint Venture Firm, lead partner and other partners.*
4. *The lead partner and the other partners shall have minimum 51% and 20 % stake respectively in the Joint Venture.*
5. *The joint venture agreement should be made on Rs. 1000/- Non Judicial stamp Paper, duly Notarized /registered. Each partner of the joint venture shall be individually registered in the appropriate class required for participation in the tender or if eligible for registration, can also participate after having applied for registration in appropriate class.*

Also, the financial experience and physical performance of the bidder will not be taken in to consideration for the works executed as a subcontractor. However, the same will be taken in to consideration if the work is executed for Government Organization /Undertaking /Municipality /Corporation and the financial turnover of the Main Contractor is more than Rs. 100 Crore in the years of execution by the bidder as a subcontractor.

7.1 The Bidder shall bear all costs associated with the preparation, submission, clarification, and to attend discussions/conference in connection of this tender. The WRD/State in no case will be responsible or liable for those costs whatsoever.

**8.0 Site Visit**

8.1 The Bidder is advised to visit and examine the site of works and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid and entering into a contract for the design-build and completion and commissioning of the works. **The costs of visiting the Site and investigation etc. shall be at the bidders own expense.**

8.2 The Bidder and any of its personnel or agents will be granted permission by the WRD to enter upon its premises and lands for the purpose of such inspection, but it is deemed that the bidder, its personnel and agents, will release and indemnify the WRD and its personnel and agents from and against all liability in respect thereof and the Bidder will be responsible for death or personal injury, loss of or Gravity concrete damage to property and any other loss, Gravity concrete damage, costs and expenses incurred as a result of the inspection.

Copies of the department's response, including a description of the enquiry, will be forwarded to all the purchasers of the bidding documents.

- 11.2 Any addendum thus issued shall be part of the bidding documents and shall be uploaded online.
- 11.3 To give prospective Bidders reasonable time to take an addendum into account in preparing their bids, the Bid Inviting Officer may extend, if necessary, the last date for submission of Bids.

## **C. PREPARATION OF BIDS**

### **12.0 Language of Bid**

- 12.1 The bid, and all correspondence and documents, related to the bid, exchanged between the Bidder and the WRD and authorized officers shall be written in the **English** language. Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant passages in the English language, in which case, for purposes of interpretation of the Bid the True English translation shall prevail.

### **13.0 Documents Comprising the Bid**

#### **13.1 The Bid comprise the following.**

#### **13.2 Price Bid**

- 13.2.1 The bidder shall quote his price in the prescribed format given in Volume—II Section III Price Proposal in Indian Rupees.
- 13.2.2 Bidders shall quote for the entire work on a firm lump sum price and on a single source responsibility basis.
- 13.2.3 The rates and prices quoted by the Bidder are not subject to adjustment during the performance of the Contract for taxes, duties and any other levies except Price Adjustment as per Clause 113 of Condition of Contract.
- 13.2.4 Notwithstanding anything that is stated, the price once accepted by the Employer shall be final and shall not be subject to any claim on any grounds whatsoever.
- 13.2.5 The bid offer shall be for the whole work and not for individual items / part of the work.
- 13.2.6 The Bidders shall have to quote rates inclusive of GST and all other taxes, levies, duties, cess, toll etc.

- 13.2.7 Bidders shall quote price in the proforma given in Vol. II, Section III (Price Proposals). The contractor is expected to quote the bid price in lump sum after careful analysis of cost involved for the performance of work complete considering all specifications and conditions of contract.
- 13.2.8 The bidder shall submit along with his bid monthly cash-flow statement based on requirement of funds (Indian Rupees) to match the Physical targets of construction.
- 13.2.9 The bidder shall pay special attention as regards achieving of critical milestones on schedule, so as to ensure final commissioning on time. The Government/WRD shall critically monitor both the Physical as well as Financial Targets, on monthly and quarterly basis. Shortfalls, if any, in the monthly targets shall be immediately rectified by supplementing the resources by the contractor leading to increase the progress, so as to achieve the quarterly targets as per schedule.

### **13.3 Construction Programme**

- 13.3.1 The Bidder shall include in his Bid (Envelope B), a detailed construction programme of executing the Project, describing broadly the Technology and Construction Methodology of MEDIUM Components of the Project including survey, investigation, soil exploration, design & Engineering, estimation, land acquisition, construction and completion of total project, trial run of total system. The programme shall be supplemented with Master Control Network. The copy will be submitted with the PQ Document (Envelope 'B').
- 13.3.2 The Government /WRD reserve the right to request for changes in the Master control Network during pre-award discussions with the responsive bidder. Mutually agreed Master Control Network shall form part of the Contract.

### **14. Bid Form and Price Schedule**

- 14.1 The Bidder shall complete the Bid Forms and schedules furnished in the bidding documents in the manner and detail indicated therein, following the requirements of Clause 13.2 and 15. 16.1.1 Bids shall remain valid for a period of not less than **180 (One Hundred Eighty) days** after the last date of submission of bid.

### **15. Bid Currencies**

- 15.1 All prices shall be quoted in Indian Rupees.

### **16. Bid Validity**

- 16.1.1 Bids shall remain valid for a period of not less than **180 (One Hundred Eighty) days** after the last date of submission of bid.
- 16.2 During the above-mentioned period no plea by the Bidder for any sort of modification of the Bid based upon or arising out of any alleged misunderstanding, misconceptions or mistake or due to any reason(s) whatsoever will be entertained.

- 16.3 In exceptional circumstances, prior to expiry of the original time limit, the **Chief Engineer Hasdeo Basin WRD Bilaspur** may request the bidders to extend the period of validity for a specified additional period. Such request to the Bidders shall be made in writing. A Bidder may refuse the request without forfeiting his E.M.D. A Bidder agreeing to the request will not be permitted to modify his Bid, but will be required to extend the validity of his E.M.D. for the period of the extension.

## 17. Earnest money Deposit

- 17.1 (1) The tenderer shall submit the earnest money of Rs. 1.71 lacs (Rupees One Lakh Seventy One thousand Only) For online tenders, the earnest money shall be deposited electronically by NEFT/RTGS. Internet Banking. Debit/Credit Cards on any other online process of payment. Contractor is required to generate a challan through e- procurement system for specific tender before transfer of fund and system generated challan may be submitted to bank physically for RTGS/NEFT or contractor may use other online option for making payment in account number shown in the online generated challan.

It is clarified that every contractor's challan number will be different for each challan generated from system of different or same tender, The cost of money transfer (Including payment gateways commission etc.) has to be borne by the contractor. It is advised that the contractor should consider the time taken to process the payment electronically (i.e. NEFT/RTGS, Net banking, credit/debit cards) No. Interest shall be payable to contractors on amount deposited as earnest money.

  - (2) The Earnest Money in one of the prescribed forms above should be submitted separately in **Envelope – A** and not kept in the covers containing the Prequalification or Price tenders and if the Earnest Money is not in accordance with the prescribed mode and the amount, the tender (Envelope 'B' and Envelope 'C') will be returned unopened to the Tenderer.
  - (3) Any tender not accompanied by an acceptable EMD or not being valid as described in Clause 11.1 (1) of Tender Document Volume-II, Section-II, will be treated as non-responsive and rejected by the Department. The EMD of the unsuccessful Tenderers will be discharged/ returned after an agreement is entered into with the successful bidder whose tender has been accepted or after expiry of bid validity period whichever is earlier.

- 19.2 The purpose of the meeting will be to clarify issues and to answer questions on technical matters only and if necessary to correct tender conditions or clause. No written reply to the points raised will be given.
- 19.3 The Bidder is required to examine and check the Government/WRD's Design Criteria including specifications, included in the tender document, and inform of any changes logical or otherwise during or prior to the pre-Bid meeting in writing
- 19.4 The Bidder may submit questions if any, in writing, or by fax, to reach the **Chief Engineer Hasdeo Basin WRD Bilaspur (C.G.)** not later than 3 days before the date of meeting.
- 19.5 Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a bidder. Nevertheless, bidders may participate in the pre-Bid meeting to help ensure that they fully understand the key concerns of the department and the department's requirements.

**20. Format and Signing of Bid**

- 20.1 The application is invited for the work as detailed in the brief note. The pre-qualification documents in prescribed form duly completed and signed shall be submitted.
- 20.2 The original Bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the bidder. Application should be type written and applicants name must be appear on each page of the application. Over writing should be avoided, mistakes should be scored through the correction incorporated and attested with the applicants initials in ink.
- All qualification documents shall be numbered and submitted as a package with the signed. Contract obtained on the basis of fictitious documents will be nullified and the earnest money forfeited and bank guarantee will be en cashed in the favour of the Government reserving the right to take other legal action.**

The Bidder shall sign on the cover page of the documents, to confirm that he has read and accepted all the contents and conditions contained therein, and shall affix his signature on all pages of Volume I, Volume II and Volume III as mentioned in the sub clause 9.0 In addition, all pages of the Bid where entries or amendments have been made shall be initialled by the person or persons signing the bid.

- 20.3 The Bid shall contain no alterations, omissions or additions, except those to comply with instructions issued by the **Chief Engineer Hasdeo Basin WRD Bilaspur (C.G.)** or as necessary to correct errors made by the bidder, in which case such corrections shall be in tailed by the person or persons signing the bid.



- 20.4 The cost incurred by the applicant in preparing this application, in providing clarifications or attending discussion, conferences in connection with documents shall not be reimbursed under any circumstances.
- 20.5 Bidder shall collect all information on existing infrastructure like approach to construction area, power telecommunications etc., and satisfy himself prior to submission of his / their bid.

#### **D. Preparation & Submission of Bids**

##### **21. Marking of Bids**

The bid data should be filled and the bid seals (Hashes) of all the envelopes and the documents which are to be uploaded by the bidders should be submitted online. The contractors shall submit the pre-qualification information in the prescribed proforma for assessment of eligibility in online Envelope-B with price bid in a separate online Envelope-C.

- 21.1 The bid data should be filled and the bid seals (Hashes) of all the envelopes and the documents which are to be uploaded by the bidders should be submitted online. The contractors shall submit the pre-qualification information in the prescribed proforma for assessment of eligibility in online envelope -B with price bids in form Volume II in a separate on line envelope- C

- 21.2 The tenderers' are advised to go through the pre-qualification documents carefully and furnish the required details duly supported by documentary evidence (which must be self-attested), as their eligibility for this contract. Prequalification shall be decided on the basis of the information/documents submitted by them in online Envelope "B".
- 21.3 The bidder shall have to submit their bids online and upload the relevant documents.
- 21.4 Since the bids for the tender required to be digitally signed using class III digital certificate of the authorized representative of the firm, contractors are advised to obtain the same at the earliest. - 21.5 The Earnest Money Deposit Envelope (Envelope - 'A') and Envelope – 'B' shall be opened online in the presence of any intending contractors or their representatives, if they choose to be present. After assessment of eligibility of the tenderers by the competent authority on the basis of pre-qualification documents submitted by the Contractors in online Envelope–'B'. Envelope– 'C'(Price Bid in Envelope–'C') of only pre – qualified Contractors shall be opened online. The Start Date & Time and the End Date & Time of opening of Price Bid envelope mentioned in the Tender schedule is tentative and subject to change. The pre - qualified Contractors shall be intimated of the final date and time of opening separately.

- Pre-qualification document (Volume-I) containing details regarding eligibility for pre qualification, enumerated in "Instructions to Bidder" Section –III in the prescribed proforma as Technical Schedule i.e. Form 1A, 1B, 2A, 2B, 2C, 2D, 3A, 3B, 3C, 3D, 3E, 3F, 4A, 4B, 5, 6 and Form-7 and these Format should be supported by certificates wherever necessary signed by the officer not below the rank of Executive Engineer. The certificate should be translated in English and attested, if issued in some other Indian language). Applicant shall attach all necessary documents like audited Balance sheets, CA Certificates, Experience certificates, Technical Design as described in Pre-qualification document

21.7 If the outer and inner envelopes are not sealed and marked as above, the WRD will assume no responsibility for the misplacement or premature opening of the tender.

**22 Deadline for submission of online Bids**

22.1 The bidder shall have to submit their bids online and upload the relevant documents.

22.2 The Chief Engineer, Procurement (C.G.) may extend the dates for receipt of Bids by issuing an amendment in accordance with Clause 11 in which case all rights and obligations of the **Chief Engineer Hasdeo Basin WRD Bilaspur** and the bidders previously subject to the original deadline will thereafter be subject to the deadline as extended.

**23 Late Bids**

23.1 Any Tender received by the Government/WRD after the deadline for submission of bids will not be entertained.

**24. Modification and Withdrawal of Bids**

24.1 The Bidder may modify or withdraw his bid online prior to the deadline prescribed for submissions of bids.

24.2 No bid may be modified after the deadline prescribed for submission of bids.

**E. Opening and Evaluation of Technical Proposals**

**25. Opening of Pre-qualification Document**

25.1 The Earnest money deposit Envelope (Envelope-A) and Envelope-B shall be opened online in the presence of any intending contractors or their representatives, if they choose to be present after assessment to eligibility of the tenderers by the competent authority on the basis of pre-qualification documents submitted by the contactors in Envelope-B.

25.2 No application of the tenderers shall be entertained between the period of submission and opening of tender

25.3 First Envelope -A shall be opened and if following found in order then only Envelope-B shall be opened.

- (a) Copy of Receipt of cost of Tender Document.
- (b) Copy of Receipt of e-EMD.
- (c) Copy of registration certificate, and
- (d) Affidavit as per Annexure-4
- (e) additional affidavit as per Annexure-5
- (f) Joint Venture Agreement, If Any.

\*In case of JV, ref. clause 16 of NIT, Volume-II and Clause 4.5 of Section –I, Prequalification Document Volume-I.

- 25.4 After opening Envelope-B based on the information given in the document by the tenderer, evaluation of pre-qualification will be carried out as per norms / criteria given section II clause 2 “Qualifying criteria” of pre-qualification document (Volume -I) Pre-qualification of the bidder will be decided by the competent authority.
- 25.5 After assessment of eligibility of the tenderers by the competent authority on the basis of pre - qualification documents submitted by the contractors in Online Envelope-B, Envelope-C (Price bid) of only pre-qualified contractors shall be opened online. The start date and time and the End date and time of opening of price bid Envelope mentioned in the tender schedules is tentative and subject to change the pre-qualified contractors shall be intimated of the final date and time of opening separately.
- 25.6 The bidder who does not pre-qualify as per prescribed norms, his price bid (Envelope-C) will not be opened. The Envelope-C
- 25.7 The Bidder shall furnish the clarification called for within the stipulated time and, will be disqualify in the event of failure to do so.

## **26 Examination of Bids and Determination of Responsiveness**

The Employer will evaluate whether each Bidder is satisfying the eligibility and qualifying criteria prescribed in the pre-qualification document and declare names of the qualified Bidders.

- 26.1 If any alteration is made by the Bidder in the Bidding documents, design parameters, specifications etc. the Bid is liable to be rejected.

### **26.2.1 Step I - Preliminary screening for completeness and responsiveness.**

- a. Prior to the detailed evaluation of the bids, the Government/WRD’s authorized representative will determine whether each bid (i) is accompanied by the required Earnest Money (ii) has been properly signed; (iii) is responsive to the requirements of the bid documents; and (iv) provides any clarification and/or substantiation that the Government/WRD’s authorized representative may desire.
- b. A substantially responsive bid is one, which conforms to all the terms and conditions of the bid document without material deviations. A material deviation or reservation is one (i) which affects in any substantial way the scope, quality or performance of the works or its feasibility of execution in reasonable time (ii) which limits in any substantial way, the Employer’s rights or bidder’s obligations under the contract (iii) whose rectification would affect unfairly the competitive position of any bidders presenting substantially responsive

bids (iv) which is incomplete or does not include all the works covered by the scope of works.

#### **26.2.2 Step II -Assessment**

The detailed assessment for pre-qualification shall be based on the information submitted by the Bidder with reference to prequalification criteria fixed under section II, pre-qualification requirement. Competent authority at its discretion may pre-verify the authenticity of the documents submitted.

#### **27 Price Bid Opening:**

27.1 Envelope 'C' (Financial Bid) shall be opened online at the time and date notified. The bidder shall have freedom to witness opening of the Envelop 'C'.

#### **28. Evaluation and Comparison of Price Bids**

28.1 After opening Envelope 'C' all responsive bids shall be compared to determine the lowest evaluated bid.

28.2 Tie breaker among those bidders who submit the lowest evaluated & equally quoted Bid will be in the following order:

- a) The Bidder with higher bid capacity.
- b) The Bidder with higher average annual turnover.
- c) The bidder with higher Net Worth.

#### **29. Discrepancy in Contract Price quoted.**

29.1 In case of any discrepancy between the overall Contract price quoted in words and figures, then whichever is lower shall prevail.

#### **30. Process to be Confidential**

30.1 Information relating to examination, evaluation, comparison and recommendation of contract award shall not be disclosed to bidders or any other person not officially concerned with such process until final decision on the bid.

30.2 Any attempt by a bidder to influence the Employer in the evaluation of the bids or contract award decisions may result in the rejection of his bid.

30.3 Before recommending / accepting the Bid, the Bid recommending / accepting authority may verify the correctness of certificates submitted to meet the eligibility criteria and specified experience.

30.4 Policy for Bids under Consideration:

Bids shall be deemed to be under consideration immediately, after they are opened and until such time official intimation of award / rejection of bid is communicated by the Government/WRD. While the bids are under consideration, Bidders and / or their representatives or other interested parties

are advised to refrain from contacting by any means, the government / WRD and / or his employees/ representatives /consultants on matters related to the bids under consideration. To assist in the examination, evaluation and comparison of bids, the Government/WRD's authorized representative may, at his discretion, ask any or all bidders for clarification of his / their bids, including breakups of prices, technical information, documents and materials after opening of the bid. The request for clarification and the response shall be in writing but no change in the price or substance of the bid will be sought, offered or permitted. The bidders shall submit all clarifications / additional documents in one original and two copies.

- 30.5 The Bidders whose bid is not accepted shall not be entitled to claim any costs, charges and expenses of and incidental to or incurred by him through or in connection with his submission of bid, even though the Government/WRD may elect to modify / withdraw the invitation to bids.

## **F. Award of Contract**

### **31. Award Criteria:**

- 31.1 The Employer will award the contract to the Bidder who is found qualified as per the Bid conditions and whose price bid is lowest. Once the contract is awarded to the successful bidder as above, all other bids shall be deemed to be rejected.
- 31.2 The department reserves the right to accept or reject any bid or all Bids and to cancel the Bidding process, at any time prior to the award of Contract, and shall not bear any liability for such decision and shall not have any obligation to inform the affected Bidder or Bidders of the reasons thereof.

### **32. Notification of Award**

- 32.1 Prior to expiration of the period of Bid validity prescribed in tender document, the Employer or his nominee will notify the successful Bidder on Departmental Website & or by Ordinary post that its Bid has been accepted. This letter (hereinafter and in the Conditions of Contract called the "Letter of Acceptance") shall notify the sum which the Government/WRD will pay to the Contractor in consideration of the execution, completion of the project by the Contractor as prescribed by the Contract (hereinafter and in the Conditions of Contract called "the Contract Amount").The notification of award will constitute the formation of the Contract.
- 32.2 The signing of contract agreement shall be reckoned as intimation to commencement of work. No separate work order shall be issued by the Employer to the contractor for commencement of work.

### **33. Signing of Contract Agreement**

- 33.1 Tenderer whose tender has been accepted (hereinafter referred to as contractor) will execute the agreement with the **Executive Engineer, Water Resources Division Kota (C.G.)**, in the prescribed form, within 15 days from the date of communication of acceptance or any such date extended by

the competent authority in writing. Failure to do so, will result in the Earnest Money being forfeited to Govt. and tender being cancelled.

- 33.2 The signing of contract agreement shall be reckoned as intimation to commencement of work. No separate work order shall be issued by the Employer to the contractor for commencement of work.

**34. Performance Security**

- 34.1 Within 15 days of receipt of the notification of award from the Employer, the successful Bidder shall furnish a performance security amounting to 1 percent of the Contract value or Rs. 10.00 lacs whichever is more in accordance with the Conditions of Contract. The form of performance security provided in the bidding documents may be used.
- 34.2 Failure of the successful Bidder to comply with the requirements of Clause 33 or Sub-Clause 34.1 shall constitute sufficient grounds for the annulment of the award and forfeited of the Earnest Money.

**35. Fraudulent Practice**

- 35.1 "Fraudulent Practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Government, and includes collusive practice among Bidders (prior to and after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive the Government of the benefits of free and open competition.
- 35.2 Govt./WRD will reject a proposal for award if it determines that the Bidder recommended for award, has been engaged in fraudulent practices in competing for the contract in question;
- 35.3 Govt./WRD will declare the bidder ineligible, either indefinitely or for a stated period of time, for awarding Government-financed contract if at any time it determines that the firm has been engaged in fraudulent practices in competing for, or in executing the contract.

## PRE-QUALIFICATION CRITERIA BHAISAJHAR LIFT IRRIGATION SCHEME

### General

- 1.1 Bidders including joint ventures should be competent & experienced contractor qualifying on the financial and experience criteria detailed hereinafter.
- 1.2 This is an EPC (Engineering Procurement Contract) where Bidders are required to Design and Implement the complete project with detailed survey investigation and design. Bidders shall therefore submit details of technical design proposal with drawing and work method, construction schedule backed with their planning and deployment of construction equipment etc. in sufficient detail to demonstrate the adequacy of bidder's capacity to design and complete the works in accordance with the specification and time of completion. He should submit his best techno-economic design proposal using WRD's DPR as a guideline. This shall be evaluated as to technical feasibility and feasibility for completion in the given time period. Only technically feasible proposal which can be completed within the time period specified in the tender and which meets the technical standards and specified conditions mentioned in this tender shall be considered as responsive. Bidder will be bound by those design details that he submit for turnkey proposal. **However it may be noted that certain design criteria are fixed in this tender and the bidder has to design within the ambit of this criteria only. This design criteria is detailed as below-**

### Design Criteria-

- 1) IS standards, latest circulars issued by E in C BODHI for Pressure irrigation Network are to be followed by strictly.
- 2) Bidders shall submit with the PQ documents, a detailed design, specifications for the laying of M.S./DI/HDPE piped canal and disnet up to 1 ha chak to irrigate 135 Ha. of CCA in Kharif, shall be designed . The scope of work requires that the pressure at each 1 ha outlet shall not be less than 20 m.
- 1.3 Bidders should fill in the forms given in Section – III of this document.
- 1.4 An **affidavit** should be submitted by the bidder(s) stating that all the documents submitted by them in support of their qualification are true. **In case of submission of false affidavit suitable action as per civil and criminal law will be taken against the bidder(s) in addition to disqualifying them from this tender at any stage even after agreement and imposing such penalties/taking such legal recourse to recover such losses as may have been incurred by the Government by such an act of the bidder. In case of joint ventures, it shall be the duty of the partners to examine before submission documents submitted by each. If the documents of a JV are found to be false then all the partners shall be liable for action as above.**
2. Qualifying criteria

- 2.1 The bidders should meet the following minimum criteria for pre-qualification in addition to that required under clause 1.1,1.2,1.3 and 1.4 above----

**Note:** In case of work executed in the past as joint ventures the certificates enclosed in support of the qualification criteria should indicate their shareholding/specific part of responsibility in those joint ventures. Qualifying parameter shall be taken into account only to the extent of shareholding / specific part of responsibility mentioned in the JV agreements of those contracts, irrespective of any certificates issued by any authority post bid in that tender in favor of any JV partner granting him a different share of experience in that executed work. Copies of those joint ventures agreements forming part of those Contract Agreements should be enclosed with the pre-qualification document failing which it shall be deemed that the bidder had zero shareholding in those contracts cited for gaining pre-qualification.

#### I Financial criteria

##### 1. The Bidder should have, following five financial years 2020-21 to 2024-25, audited:-

- 1.1 **Average annual construction turnover-** The bidder or JV should have Average Annual Construction Turnover equal to or more than 60% of PAC in last 5 financial years.

##### 1.3 Bid Capacity: **APPLICABLE**

Tenderer (Bidder) who meet the minimum qualification criteria stipulated in 1.1&1.2 above shall be further evaluated for assessed bid capacity as under :-

Assessed bid capacity  $(1.5 \times A \times B) - C - L \geq \text{Bid Amount}$

- A - Maximum value of Civil engineering works executed in any one year during last five years (10% weight-age per year shall be given to bring the value of work executed at present price level) experience of subsidiaries / subcontract and private work shall not be considered.
- B - Prescribed completion period in years.
- C - Amount of balance works in hand with tenderer at the time of receipt of tender.
- L - Value of works for which the tenderer is the lowest bidder and his tender is under consideration.

The department may verify the certificates at any time of tendering process or work execution even after agreement. Therefore, the tenderer are advised to keep the original copies of the supported documentary evidences regarding their eligibility.

##### 1.3 Experience Criteria: -

Should have a minimum financial turnover value of **CIVIL ENGINEERING WORKS** successfully executed worked out as under in any one year during the year from **2020-21 to 2024-25** (10% weight-age per year shall be given to bring the financial turnover to present price level)

To qualify for award of the contract, each prime contractor in the same name and style (tenderer), in its name must have in the year from **2020-21 to 2024-25** Achieved in "any one financial year" a financial turnover (in all classes of civil engineering construction works) of construction work of at least 60% (sixty percent) of the probable amount of contract for which bid has been invited,

- (a) (i) **Satisfactorily completed at least one similar work equal in value 50% (fifty percent) of the probable amount of contract as on date of submission of financial offer.**

**OR**

- (ii) **Satisfactorily completed at least two similar work each costing minimum 40% (forty percent) of the probable amount of contract for which the tender invited as on date of submission of financial offer.**

Only technically feasible proposal which can be completed within the time period specified in the tender and which meets the technical standards and specified conditions mentioned in this tender shall be considered as responsive.

The clarification regarding technical qualification details can be obtained by the department at any time and shall be binding on the bidder to provide it and any change/rectification in submitted design proposal is permitted to suit the requirements of the work.

Note:-

1. The Bidder shall be liable for forfeiture of his earnest money deposit, if any document / information are found false/ fake/ untrue before acceptance of bid. If it is found after acceptance of the bid, the bid sanctioning authority may at his discretion forfeit his performance security/ guarantee, security deposit, registration deposit and take any other suitable action.
2. Works executed in India with Central Government or any State Government or Semi Government organization or Central/any state Government Authority or Government of India/any State Government undertaking or Municipalities/Municipal Corporations will only be considered. Certificates issued by the private individuals or private companies or private firms, for whom such works are executed or being executed, shall not be accepted unless their annual turnover is more than Rs. 500 Crore in the years of execution. Such certificates shall be supported by the balance sheets of the respective years of execution and shall be duly certified by the Chartered Accountant.

4. In case of PPP projects, certificate of either a Chartered Accountant appointed for the PPP projects or a Government agency or an Independent Engineer appointed for the PPP project will be acceptable in favour of the bidder subject to his share in the SPV formed post PPP bid by that bidder as per the terms of the concession agreement drawn under the PPP Contract.

5. If the financial turnover/ physical experience of the firm other than the title name is included then that/those firm/firms shall also be liable for action like suspension of registration or blacklisting in case of any default.

6. The turnover of the years prior to 2024-25 shall be given weight age of 10% per year to bring them to price level of 2024-25.

7. Any clarification on Documents submitted by the Bidder may be called by the Department and the Bidder shall submit the same within the stipulated time

#### IV Disqualification

Even though the bidder satisfies the above requirements they are subject to be disqualified –

- (a) If the design submitted by the bidder does not fulfil the criteria in general, his offer is liable for disqualification.

In case the tenderer enters into an agreement and it is found that he was awarded the contract based on misleading, incorrect, incomplete or false information, his EMD for the tender shall be forfeited and his Pre-Qualification (PQ) certificate issued by the Department shall be cancelled for one year but the agreement shall not be revoked.
    - (ii) Cancelled or suspended the registration of the firm.
    - (iii) Registration was cancelled or suspended before five years and not revoked up to the date of bid submission.
    - (iv) Black listed the Contractor.
    - (v) Debarred the Contractor for participating in future tendering.
    - (vi) Termination of contract due to default of contractor.
    - (vii) Forfeiting of full or partial SD for poor performance. (including cases where the forfeiting has been done in last 5 years) though the contract period/case may be older than 5 years.
  - (d) If a proceeding for suspension or cancellation of registration or for blacklisting or for termination of a contract due to poor performance by the contractor has been started by the Department of Government of CG before the issue date of this tender and the same is subsisting on the date of submission of the bid.
  - (e) The Employer reserves the right to accept or reject any bid, and to annul the bidding process and reject all the bids at any time prior to contract award, without incurring any liability. In all such cases reasons shall be recorded.
- **Provided the above said penal actions were in force on the last date of submission of the bid.**
  - **In case of JV all the partners shall be required to submit an affidavit giving full information of above facts.**

**Disqualification:-**

Even though the Tenderers satisfy the above, they are subject to be disqualified if :

- i. Made misleading, incorrect, incomplete or false representation in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements.
- ii. If the tenderer produces misleading, incorrect, incomplete or false information regarding qualification requirement, then the EMD for the tender shall be forfeited and his pre-Qualification (PQ) certificate issued by the Department shall be cancelled for one year. In case the tenderer enters into an agreement and it is found that he was awarded the contract based on misleading, incorrect, incomplete or false information, his EMD for the tender shall be forfeited and his Pre-Qualification (PQ) certificate issued by the Department shall be cancelled for one year but the agreement shall not be revoked.
- iii. Tenderer not produce all original certificates for verification of the certificates submitted for pre-qualification requirements as and when demanded by the department.
- iv. Participated in the previous bidding for the same work and not executed the agreement.
- v. Record of poor performance such as abandoning the work, not properly completing the contract, unsatisfactory quality of work, inordinate delays in completion, claim and litigation history, or financial failures etc. in any department of Govt. of Chhattisgarh or the State Govt. organization / services / corporations / local body etc. (by whatever names these are called).
- vi. One person involving in two or more registration in the same tender.
- vii. If the tenderer whose bid is found lowest does not submit the required documents of Envelope - A within time limit, the tender process stands vitiated. Such tenderer is responsible for causing wilful disruption of tender process. Action of de-registration shall be recommended for a period of minimum two years for such tenderer in conformance with the provision made in order vide Govt of CG., PWD order no F 5-8/19/2013/निविदा Dt 29.10.2014.
- viii. The tender has to be re-invited. The amount of EMD shall be recovered from the defaulted tenderer of the FIRST CALL from his ongoing works within the WRD and amount deposited during unified registration in PWD or from revenue recovery.
