

## **NOTES**

- 1 The contractor shall exhibit a board as per Government Circular No. Vernacular TNC/1090/25 S Dated 18-11-1991 detail specification and details of works and amount involved at site at the own cost as directed by Engineer in charge
- 2 Testing of materials shall be as per statement attached with the specification. The materials shall be tested in G.E.R.I. Bill of testing charges shall be paid by the Executive Engineer and 1% computed after deducting the cost of materials to be supplied by the Government at the estimate rate shall be recovered from the contractors running bills for as per G.R. (R & B) Deptt. no. T.N.C.-1085- (4)-C, dt. 20-12-1992.
- 3 In R.C.C. Item where there is charge of grade mix or charge as per actual mix design the difference of cement consumption shall be add/deducted from rate of original item at the rate of star rate mentioned in the tender.
- 4 All work shall be carried out as per P.W.D., H.B.T.S. Specification & other specification of Division or as directed.
- 5 All the columns in the Schedule-B should be filled in INK and total of the entries in the last column should be struck by the contractor under his signature.
- 6 Rates quoted includes clearance of site (Prior to comments of work and its close) in all Respects and hold good for work under all conditions, site, Moisture, weather etc.
- 7 Contractors shall state even 'NIL' presentage if no-deduction is offered.
- 8 For earthquake resistance provision the work shall be carried out as per the instruction of Engineer in charge.
- 9 The other conditions of Schedule-B will remain unchanged.
