- b. All the bidders will be required to pay Tender Fee plus applicable GST as mentioned in the Tender Document either in Cash (up to Rs. 10,000/- only) at the office address specified in the tender documents or by RTGS / NEFT / Online.
- c. If the EMD amount is more than Rs. 3.0 Lakhs, it should be paid either by RTGS / NEFT / Online or Demand Draft or Banker's Cheque or Pay order or Bank Guarantee. Otherwise, it should be paid either in Cash (up to Rs. 10,000/- Only) at the office address specified in the Tender Documents or by RTGS / NEFT / Online.
- d. In case of payment of Tender fee & EMD through Demand Draft or Banker's Cheque or Pay order or Bank Guarantee or receipt of payment in Cash, the scanned copy of original documents shall be uploaded in preliminary stage and original copy of the same will be submitted only by Registered Post A.D. or Speed Post and same must be submitted on or Before Schedule Date and time and ensure that Tender Number must be mentioned on the sealed cover.
