Note for EMD:

1. P.O. for approx. 75-85% quantity will be given to L1 party in e-auction/tender and P.O. for approx. 15-25% quantity will be given to L2 party @L1 rate for that material. Plant wise allocation to L1 & L2 is given in above table. However the above plant wise allocation is tentative and we may vary the quantity at the time issue of Purchase Order as per plant requirements.
2. Bank guarantee for more than Rs. 5 lakh is acceptable.
3. Vendors have option for one-time deposit of EMD for the financial year. In such case vendor has to give a declaration for keeping his/her EMD deposited for future tenders.
4. Normally Delivery Period will be according to the PO quantity - 15 Days upto 100 MT, 25 Days for DORB, 30 Days for Molasses/Calcite/Salt and 20 Days for all other POs. OR as mentioned in Purchase Order in case of special requirement.
5. All Cattle Feed Raw Materials, Minerals, Supplements shall be FREE from any ingredients originated or derived from any animal source including animal remains or residue as per BIS standards for compounded cattle feed.
