

:: PQ CRITERIA ::

Name of work: - Providing & Erecting Temporary LED Screen,Videography and Multimedia setup in Side Dome for Hon'ble PM Sir's Upcoming Event During Visit in any District of Bhuj Electrical Division Jurisdiction. (Kachchh, Morbi, Surendranagar)

[1] D.D. for Tender Fee.

[2] EMD in form of the FDR only. (Minimum for 165 Days from the last date of online submission of tender.) Exemption certificate will not be considered/accepted.

[3] Certified copy of Income Tax PAN Card.

[4] Solvency Certificate of Scheduled/ Nationalized Bank for current calendar Year (2026) / should be valid at the time of opening the Tender (Minimum 20Percentage of amount put to tender).

[5] Latest valid license of Electrical Contractor issued by the IMP or Energy & Petrochemical Department. Renewal Receipt will not be considered/accepted.

[6] Valid Registration Certificate in appropriate class (E1 or Above)

[7] Essential experience in Form 3A (which is online submitted by the bidder) of Hon`ble Prime Minister of India program that has successfully completed in last five years in Gujarat state. One similar work of Hon`ble Prime Minister of India program in the Gujarat state. The Form 3A amount shall not be less than 50Percentage of the tender amount (i.e.Rs.14,33,568/-). (From-3A amount will be calculated as follows: (1) if the work is completed on or before Nov-2023, then 18Percentage GST amount will be deducted from the amount shown in Form-3A which is online submitted by the bidder. (2) if the work is completed after Nov-2023 then full amount as per the Form 3A which is online submitted by the bidder will be consider/accepted.)

Similar work means having an experience of LED Screen, Live video and watch out software Work in the program of the Hon`ble Prime Minister of India, in the state of Gujarat.

Only Videography and Photography Works will not be consider/accepted.

If the Work (shown in Form-3A) carried out/Organized by State Government, then only it will be considered/accepted.

[8] The bidders should have GST registration. (Certified copy of registration).

[9] Bidder has to submit affidavit on 300 Rupees Stamp paper that, it (bidder) is not blacklisted by any government department of Gujarat or any other state. (Annexure-I)

[10] The Bidder must submit on affidavit on 300 Rupees Stamp paper as stated in Annexure-II.

[11] Annual turnover in any one of the last Five Financial years (2020-2025), ending 31st march of the previous financial year, should be at least 2 times of the estimated cost put to Tender. (i.e. Rs. 57,34,271/-) Bidder has to submit turnover certificate which is verified and authorized by Chartered Accountant. The UDIN mandatorily mentioned on the turnover certificate.

[12] Scanned copy of all the Documents mention in the PQ Criteria must have to be submitted online. Otherwise bid will not be considered/accepted.

[13] The experience certificates in form 3(A) issued by Event Management company or private organization, Board/Nigam, corporation function will not be considered. Sublet work will not be considered. many works clubbed together such as annual rate contract works will not be considered. Other than state government program such as board, Nigam, corporation experiences will not be considered.

[14] Performance security :

(A) Within 10 (Ten) days of receipt of letter of acceptance, the successful bidder shall furnish to the employer an irrevocable and unconditional guarantee from a bank in the form set forth in section 8 (the "Performance Security") for an amount equal to 5Percentage (five percent) of its contract price. In case of bids mentioned below, the successful bidder, along with the performance security, shall also furnish to the authority an irrevocable and unconditional guarantee from a bank in the same form given at section 8 towards an Additional Performance Security (The "Additional Performance Security") for an amount calculated as under :

(a) If the contract price offered by the selected bidder is lower than 10Percentage but up to 20Percentage of the Estimated project cost, then the additional performance security shall be calculated at 20Percentage of the difference in the (i) Estimated Project Cost (as mentioned in bid document)-Minus 10Percentage of the Estimated Project Cost and (ii) Contract price offered by the selected bidder.

(b) If the Contract Price offered by the selected bidder is lower than 20Percentage of the estimated project cost, then the additional performance security shall be calculated at 30Percentage of the difference in the (i) Estimated Project cost (as mentioned in bid document) – Minus 10Percentage of the Estimated Project Cost and (ii) Contract price offered by the selected bidder.

(c) The Additional Performance security shall be treated as part of the Performance security.

(B) The Performance security shall be valid beyond 60(sixty) days of the defects liability period and the additional performance security shall be valid beyond 28 (twenty-eight) days of project completion date.

[15] Price bid will be opened for those Bidders who qualify pre-qualification criteria.

[16] GST is not Included in the rate of Items shown in Schedule-B, it will be paid separately.

[17] For any dispute subject to Bhuj jurisdiction.

[18] The bidders who do not furnish full details and all the documents as listed above or furnish incomplete or insufficient details or documents will be treated as non-responsive & their price bid will not be opened. The documents as listed above shall be submitted in Electronic format only through online (by scanning) while uploading the bid. This submission shall mean that E.M.D. & tender fee are received. Accordingly offer of those shall be opened whose E.M.D. & Tender Fee is received electronically. However, for the purpose of realization the bidder shall send the DD/FDR in original through R.P.A.D./Speed Post so as to reach **Executive Engineer, Bhuj Electrical (R & B) Division, Bhuj.** within 7 Days from the Last date of the bid Submission. Punishable action for not submitting D.D. in original to Executive Engineer, by bidder shall be initiated. GST Liability will be of Agency..

[19] ESCALATION FACTORS

Following enhancement factors will be applied to annual turnover and completion cost of works to bring them to the base year. The current financial year in which bid is invited shall be considered as the base year.
