(website) **http://eproc.cgstate.gov.in** directly and shall be submitted online only after making the payment of Bid submission fees online. The bids of the contractors have to be digitally signed by the Digital Certificate of the Contractor before submitting the bids online.

All the contractors are compulsory required to submit Online upload scanned copy of following documents:-

- For online Tender, The Earnest Money, as specified, shall be deposited electronically, according to the Clause 3.2.1 of Appendix 2.10 (Detailed Notice Inviting Tender).
- Copy of Registration certificates..
- Copy of Valid **"A"** Registration certificate issued by C.G. Electricity Licensing Board (In the name of firm/Partner/Proprietor).
- Copy of G.S.T. Registration certificate in State of Chhattisgarh.
- Copy of valid Bank Solvency Certificate not older than 12 months.
- Income Tax clearance certificate or Income tax return statement of preceding 3 years.**

**7. For Tender value less than Rs. One Crore :-**

- (i) It is mandatory for the "B", "C" & "D" Class bidders, to submit affidavit (Annexure 3, enclosed) and the list of ongoing work/works in hand in the Annexure "2" (enclosed), if the total value of works in hand is more than 2.5 times the capacity as specified for "B", "C" & "D" class bidders registration the bidder shall be disqualified.
- (ii) It is mandatory for the "A" class Bidder, to submit affidavit (Annexure 3, enclosed) and bid capacity information (Appendix 1) along with information Annexure 1, 2. The bidder will only be qualified if the available bid capacity is equal or more than the amount put to tender.

**8. For tender value from Rs. 1 Crore to Rs. 5 Crore :-**

All bidder shall have to submit the information of bid capacity (Appendix 1) information in Annexure 2, 3 and affidavit (Annexure 3). They will only be qualified if the available bid capacity is equal or more than amount put to tender.

9. EMD Drawing, and affidavit online upload and scanned copy with original documents should also be submit in physically of Registered/Speed post.
10. In case the tenderer(s) is/are not registered in appropriate class of contractors in Chhattisgarh Public Works Department and website <http://eproc.cgstate.gov.in> He/they shall not be eligible to participate in the above tender
11. In the event of withdrawing his/her offer before the expiry of the period of validity of offer or failing to execute the agreement as required by condition No 8.1.1 of the notice inviting tender (N.I.T.) he/she will not be entitled to tender for this work in case of recall of tenders. In addition to forfeiture of his/her earnest money as per provisions of condition No 4.7 and 8.1.1 of N.I.T. as may be applicable for the work.
- This special condition will supersede any thing contrary to it, in the tender document**
12. Cess @1% (One Percent) shall be deducted at source, from every bill of the contractor by the Executive Engineer under "Building and other construction for workers welfare Cess Act 1996.
13. It is mandatory for the contractor(s) to get himself/themselves registered with "C.G. Building & other construction welfare Board" as soon as the work order is issued to him/them for the work amounting to Rs. 10.00 (Ten) Lakhs and above and submit a copy of the same of the concern Executive Engineer other wise no payment will be made under the contract.
14. Contractors are advised to go through the Notice Inviting tenders & the tender/PQ/Bid Capacity document thoroughly. Certificates, annexure, enclosures as mentioned in the document will have to be submitted by the tenders strictly in the prescribed format, at the time of submission of Technical / Financial bid, failing which the contractor shall disqualify for the work & his financial offer shall not be opened and no representation, appeal or objection, what so ever in this regard shall be entertained by the department.
15. "The reason of internet linking failure will not be entertained for extension of submission date of tender."

Envelope should be submitted with above all document & also mention the **mobile No./landline** on envelope only through Registered Post / Speed Post so as to reach in the Office of the **Superintending Engineer, Public Works Department, E&M, Circle Bilaspur, 495001** (up to the date and time mentioned above. For any postal delay the department shall not be responsible.

The contractors shall also submit the all above required document during Online Bidding submission Process.
