

## Check List for Important documents:

### Documents should be submitted along with offer:

1. Technical And Financial Eligibility Criteria is mentioned in Clause 10.1 and 10.2 Part-I of Standard General Conditions of Contract April 2022 (Page No. 12-16). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
2. <b>Definition of similar Nature Work w.r.t. Clause 10.1:</b> "Supply, Installation, Testing & Commissioning of RDSO approved Complete Graduated release Compressed air brake equipment for Rolling stock in Indian Railways" OR "Maintenance/Repair/Overhauling of RDSO approved Complete Graduated Release Compressed air brake equipment for Rolling stock in Indian Railways".
3. <b>TENDERER CREDENTIALS:</b> Tenderer credentials is mentioned in Clause 11 Part-I of Standard General Conditions of Contract April 2022 (Page No. 16-17). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
4. <b>DOCUMENTS TO BE SUBMITTED ALONG WITH TENDER:</b> Documents to be Submitted is mentioned in Clause 14, 15 and 16 Part-I of Standard General Conditions of Contract April 2022 (Page No. 17-20, Para-I to iv). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
5. <b>JOINT VENTURE (JV) IN WORKS TENDERS:</b> Documents to be Submitted mentioned in Clause 17 Part-I of Standard General Conditions of Contract April 2022. Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
6. <b>BID SECURITY:</b> Bid security is mentioned in Clause 5 Part-I of Standard General Conditions of Contract April 2022 (Page No. 4-6). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
7. <b>CARE IN SUBMISSION OF TENDERS:</b> Documents to be Submitted mentioned in Clause 6 Part-I of Standard General Conditions of Contract April 2022 (Page 6-7). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
8. <b>TENDER FORM (First Sheet): Annexure I</b> to be Submitted as mentioned in Standard General Conditions of Contract April 2022 (Page 9-10). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.

9. <b>Annexure -VIB</b> (Page 40) to be Submitted as mentioned in Standard General Conditions of Contract April 2022. Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
10. <b>BID CAPACITY (Annexure-VI):</b> Documents to be Submitted mentioned in Standard General Conditions of Contract April 2022 (Page 35-36). Document should be submitted as described in GCC April 2022 (or latest) with all correction slips.
11. Bank details as per ANNEXURE-A.
12. All the bidders/tenders should ensure that they are GST complaint and their quoted tax structure/rates are as per GST Law. (Please upload certificate of GSTIN registration).
13. Any other document other than listed above should be submitted as per GCC April-2022 (or latest) with all correction slips.
