- As per GCC July-2022, e-Tender Forms shall be issued free of cost to all tenderers.
- The required Bid Security will be acceptable On-line payment through Net Banking/or Payment Gateway payment /Bank Guarantee bond (Annexure-VIIA) well before & upto 15.00 hrs. of closing date & time of tender.

For all works	2% of the estimated cost of the work (rounded off to next Rs. 100/-)
In case Dismantling nature of work	10% of the Advertised Tender Value.

- Tenderers are required to upload proper & clear scanned copies of necessary eligibility documents i.e Mandatory Credentials, Partnership Deed, Power of Attorney, Affidavit, PAN, GST, Firm/Company registration, MOA/MOU/AOA etc. as per conditions.
- In case the date of opening of tenders happens to be holiday, the tenders will be opened on the next working day or otherwise.
- Partnership Firm/Joint Venture Firms can also participate. Joint Venture Firms shall be applicable to the works tenders of value more than Rs. 10 Crore.

**7 Minimum Eligibility Criteria (Works Tender)**

- Financial eligibility Criteria :-**The tenderer must have minimum average annual contractual turnover of V/N or 'V' whichever is less; where V=Advertised value of the tender in crores of Rupees N=Number of years prescribed for completion of work for which bids have been invited. The average annual contractual turnover shall be calculated as an average of "total contractual payments" in the previous three financial years, as per the audited balance sheet. However, in case balance sheet of the previous year is yet to be prepared/audited, the audited balance sheet of the fourth previous year shall be considered for calculating average annual contractual turnover. The tenderers shall submit requisite information as per Annexure-VIIB (as per standard tender document), along with copies of Audited Balance Sheets duly certified by the Chartered Accountant/ Certificate from Chartered Accountant duly supported by Audited Balance Sheet. (As per Rly. Board letter No. 2022/CE-I/CT/GCC-2022/Policy dated 14.07.2022, advanced correction slip No. 1).
- Authentic certificates shall be produced by the tenderer (s) to this effect which may be an attested certificate from the employer/client, Audited Balance Sheet duly certified by the Chartered Accountant etc.

**Criteria for Works Costing above Rs. 50 .00 Lakhs : (Similar Nature of work) :**

1	For work at Sr. No. 1	AT (Alumino Thermit) Welding involving end cropping etc.
2	For work at Sr. No. 2,3,4,5 & 6	Any civil work other than track work.
3	For work at Sr. No. 7	Construction of bridges with pipe & box pushing technique/crossing of underground cable/pipeline etc.

**Technical eligibility criteria for works tender:-** As a proof of experience/competency, The tenderer must have successfully completed or substantially completed any of the following during last 07 (seven) years, ending last day of month previous to the one in which tender is invited:  
iii Three similar works each costing not less than the amount equal to 30% of advertised value of the tender, or Two similar works each costing not less than the amount equal to 40% of advertised value of the tender, or One similar work each costing not less than the amount equal to 60% of advertised value of the tender.

- 8 Each tenderer should have Class-III Digital signature certificate to login for participation.
- 9 Tenderers, are requested to read all the instructions contained in the Tender Notice and Tender Documents carefully before submitting their offer so as to meet all the requisite provisions/special conditions etc.
- 10 GST will be levied as applicable as per GST Act. 2017.

"No post tender correspondence for submission of additional documents shall be entertained after opening of the Technical & Commercial offers. Even suo-moto post tender letters of the tenders shall be treated as NULL & VOID".
