
Sub: EMD and SD in Stores Procurement other than M & P.

Ref: (i) Railway Board's letter no. 2018/Trans Cell/Store Procurement dated 02.01.2019.
(ii) Railway Board's letter no. 2004/RS(G)/779/11/Pt. dated 27.03.2019.

Vide letter referred to (i) above, inter- alia, instructions on "Earnest Money Deposit (EMD) for stores tenders" and "Security Deposit (SD)/Performance Security in stores contracts (except M&P)" were issued. Certain amendments were also issued in the said instructions vide letter referred to (ii) above. Railway Board has further received representations from railways and suppliers both for review of the instructions.

2. The matter has been examined in Board and in view of above, following amendments to the above referred instructions are issued:



In case where available EMD amount is less than required SD and the successful tenderer does not deposit the balance SD amount within stipulated time, then EMD shall be forfeited and case be dealt with as that of withdrawal of offer by the tenderer as per extant instructions. 




