Sub : Incorporation of Electrical Contractor License and Supervisor Competency as special technical eligibility criteria in Works/Services contracts pertaining to General Services – Reg

Ref : Sr.DEE/M/BZA letter No. B/E.252/I/Similar Nature of Works dated 26.03.2026.

With reference to the letter cited above, Competent authority has approved to incorporate the following special technical eligibility criteria in Works/Service tenders for Electrical works pertaining to General Services, based on the voltage level of the work, irrespective of tender value, including tenders of value less than ₹50 Lakhs:

A. For Electrical Works up to 650 V :

The tenderer shall possess a valid Electrical Contractor License, issued by any State Government or Union Territory Administration, authorizing execution of electrical works up to 650 V. The contractor shall have in his employment or shall engage a person holding a valid certificate of competency issued by any State Government or Union Territory Administration for supervision of electrical works up to 650 V.

Offers not accompanied by a valid Electrical Contractor License and requisite Supervisor competency for works up to 650 V shall be summarily rejected.

B. For Electrical Works up to 11 kV :

The tenderer shall possess a valid Electrical Contractor License, issued by any State Government or Union Territory Administration, authorizing execution of electrical works up to 11 kV. The contractor shall have in his employment or shall engage a person holding a valid certificate of competency issued by any State Government or Union Territory Administration for supervision of electrical works up to 11 kV.

Offers not accompanied by a valid Electrical Contractor License and requisite Supervisor competency for works up to 11 kV shall be summarily rejected.

C. For Electrical Works up to 33 kV

The tenderer shall possess a valid Electrical Contractor License, issued by any State Government or Union Territory Administration, authorizing execution of electrical works up to 33 kV. The contractor shall have in his employment or shall engage a person holding a valid certificate of competency issued by any State Government or Union Territory Administration for supervision of electrical works up to 33 kV.

Offers not accompanied by a valid Electrical Contractor License and requisite Supervisor competency for works up to 33 kV shall be summarily rejected.
