Sub.:**System Improvement:** Inclusion of Unique Document Identification Number (UDIN) for all kinds of Certificates/GST/Tax Audit Report etc. issued by Chartered Accountant for submission with the tender document of Works Tender.

Ref.:Gazette Notification No. 1-CA (7)/192/2019, dated 02.08.2019 of the Institute of Chartered Accountants of India, published in the Gazette of India.

In the Gazette Notification No. 1-CA(7)/192/2019, dated 02.08.2019, published in the Gazette of India, it is mentioned that :-


- (i) A member of the institute in practice shall generate Unique Document Identification Number (UDIN) for all kinds of the certification, GST and Tax audit Reports and other Audit, Assurance and Attestation functions undertaken/signed by him which made mandatory from the following dates through announcements published on the website of ICAI [www.icai.org](http://www.icai.org) at the relevant time.
  - For all Certificates w.e.f. 1<sup>st</sup> February'2019.
  - For all GST & Tax Audit Reports w.e.f. 1<sup>st</sup> April'2019.
  - For all other Audit, Assurance and Attestation functions w.e.f. 1<sup>st</sup> July'2019.
- (ii) The above Guidelines shall come into force from the above dates for the various services respectively.

Presently, GCC and the Standard Conditions of Contract are silent on provision of Unique Document Identification Number (UDIN) for the Certificates/GST/Tax Audit Report etc. issued by Chartered Accountant.

To curb the malpractice of false certification/attestation by the unauthorised person & to eradicate the practice of bogus certificates, GM/ECR has approved the recommendation of PCE & PFA regarding adoption of Unique Document Identification Number (UDIN) and accordingly all tendering units are requested to ensure the inclusion of following condition in Special Condition of Contract in the Tender Document of Works Tenders for calling open tenders in future, as below:

**"The balance sheet and all other financial documents attested/certified by the Chartered Accountant (CA) to substantiate fulfilment of Financial Eligibility Criteria should be with UDIN, failing which the offer shall be considered as incomplete and will be summarily rejected without any further reference".**

Any tender notice issued for open tender on or after issuance of this letter should invariably must have the above mentioned special condition.
