

Sub: Seeking clarification on applicability of GCC Correction Slip No. 10.


Ref: Railway Board's letter No. 2022/CE-I/CT/GCC-2022/POLICY dated 04.03.2025.

Certain Zonal Railways have sought clarification regarding the effective date of implementation of GCC Correction slip No. 10, issued by Board in compliance to Hon'ble Supreme Court's order dated 08.11.2024 vide letter under reference.

The matter has been examined in detail in consultation with the Legal Directorate of Railway Board and following is clarified:-

- i. Irrespective of the date of the Contract Agreement, the Judgment of Supreme Court will apply prospectively to arbitrator appointments (ACS-10 to the GCC-2022) to be made after the date of order passed by Hon'ble Supreme Court i.e. from 08.11.2024.
- ii. For all contracts having no revised provisions of the ACS-10 to the GCC-2022, arbitrator appointments after 08.11.2024 may be done as per the Railway Board's letter No. 2022/CE-I/CT/GCC-2022/POLICY dated 04.03.2025 with mutual consent. Further, if the contractor opts for arbitration under the revised provisions of the subject ACS-10 to the GCC-2022, the same may be adopted by entering into a supplementary agreement.
