

Copy of above referred Railway Board's letter communicating instructions on "Online BG verification through IPAS" is enclosed herewith which is self-explanatory.

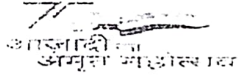
In this regard, it is mentionable that one Clause/Condition may be included in the NIT as well as in Contract Agreement for strict compliance of the Board's above mentioned instructions.

Therefore, you are requested to kindly look into the matter and necessary action may be taken to strict compliance of the instruction given in the said letter to avoid any future complicity.

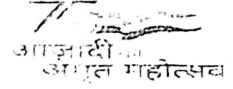


**Sub: Online BG verification through IPAS.**

The matter regarding online verification of BGs by the vendors/contractors through Structured Financial Messaging System (SFMS) platform in association with SBI was under consideration from quite some time. Now, this facility is available on IPAS. In order to avail this facility, it is necessary that following details may be entered into SFMS while issuing Bank Guarantees by vendors/contractors in favour of Railways:

**Ref:** Board's letter no. 2020/ACII/9/6/e dated 07-04-2022.

Vide letter under reference above, it was communicated that the online verification of Bank Guarantees by vendors/contractors through the SFMS platform is now enabled on IPAS.

2. Further para 10 of Annexure –VIA of IRGCC 2022, stipulates the bank to confirm that it is on the SFMS (Structured Financial Messaging System) and shall invariably send the advice of Bank Guarantee as per details mentioned.

3. In light of recent instances of frauds related to Bank Guarantee in some Railways, it is requested to confirm, whether the instructions issued vide Board's letter under Ref. and vide Para 10 of Annexure –VIA of IRGCC 2022 are being implemented in Zonal Railways to full extent. If not, then the reasons for same and issues being faced may be indicated.
