**Sub: Implementation of 'Contractor's e-MB' for Measurement and Billing of Works Contracts in IR-WCMS on Zonal Railways.**

Ref: (i) Railway Board's letters No. 2018/CE-I/CT/30 dated 29.11.2019, 21.04.2020, 12.06.2020, 04.05.2022, 24.06.2022, 30.06.2023, 01.08.2022, 05.12.2022, 26.12.2022 & 07.08.2023.

(ii) Railway Board's letters No. 2018/CE-I/CT/30/Pt.2 dated 07.08.2023 & 28.08.2023.

The IT Application of Works Contract Management System (IR-WCMS) for handling contracts has already been implemented on Zonal Railways including Zonal HQs & Construction Organizations and is being effectively used by all concerned.

2. Railway Board vide letter No. 2018/CE-I/CT/30/Pt.2 dated 28.08.2023 has issued instructions for the implementation of module of e-Measurement/Billing and extension of date of completion of EPC Contract in IR-WCMS on the 3 construction units of IR as pilot project. None of these Construction units have reported any problem/suggestion on use of e-Measurement/Billing on IR-WCMS.


3. In continuation of Railway Board's letter No. 2018/CE-I/CT/30/Pt.2 dated 28.08.2023, it has now been decided by Board (MI & MF) to launch module of 'e-Measurement/Billing and extension of date of completion of EPC Contracts' in IR-WCMS w.e.f. 07.11.2023. All EPC Contracts whose LoA have been issued on or 07.11.2023 shall be handled only through IR-WCMS.

4. CRIS will hold a VC with all concerned officials of Zonal Railways on 10.11.2023 for which link will be shared on 09.11.2023.


