The bidding for the tender can be submitted through e-tendering only on the above website during the bid submission period as mentioned above. Manual offers are not allowed against this tender and any manual offer, if received, shall not be accepted and will be summarily rejected.

Earnest Money Deposit (EMD) can be paid only through Net Banking or Payment Gateway provided in the website: www.ireps.gov.in. Fixed Deposit Receipt (FDR) will not be accepted as EMD for tenders invited on IREPS (e-tender portal).

Manual offers shall NOT be accepted against e-Tenders, even if they submit on the firm's letter head/any other form acquired or downloaded, and submitted before closing time. Any manual offer found enclosed in the envelope containing instruments/documents will be treated as invalid offer and will not be considered and shall be rejected summarily without any consideration.

Filling of e-Tenders Tenders should be duly filled in (on the assigned space), duly signed with the digital signature and submitted online. All mandatory fields marked (*) have to be filled by the tenderers.

Tenderer must fill-in the offer form (consisting of terms and conditions & special conditions etc.) and attach scanned copy of necessary documents. All the mandatory fields of the offer form (i.e. Rate page) including GST or any other taxes/duties which may become applicable during the currency of the contract and any other charges have to be filled up by the tenderer. The unit of rate shall be as indicated in the tender schedule and cannot be altered by the tenderer.

Bid Submission: -

E-bid along with the relevant documents must be uploaded and digitally signed with the digital signature of the pre-authorized personnel of the tenderer already registered with the IREPS website. Digital signature used must be "Class III-B with Company Name" obtained from G.O.I. approved Certifying Authority.

Tenderer must look out for NIT as soon as it is available on IREPS website and upload their offer well in advance without waiting for closing date and time, to avoid last minute hassles in their own computer system or communication line. Railways will not be responsible for non-participation of any contractor due to any technical problems on the day/time of tender closing.

Tenderer can submit their offer 15 (fifteen) days prior to 02-07-2026 till 14-00 hrs. The e-procurement system does not permit submission of any offer after the closing date and time of that e-tender. Hence, there is no scope of any Late/Delayed offers in the online bidding process.

Tender Opening: -

Electronic tender boxes will be opened on and after 15-00 hrs on 02-07-2026 as shown on the IREPS Website. Electronic tender boxes will be opened by minimum two authorized Railway officials using their secured digital permissions, passwords and digital private keys obtained from GOI approved certifying agencies. The icon will indicate that the tender has been opened. Tenderer shall not be required to be present in the office of Dy. Chief Mechanical Engineer(C) /Kanchrapara for any e-Tender opening process. They can obtain totally transparent bid tabulation statement by logging on the IREPS website after tender opening.

Tenderer submitted valid electronic offers can view their own offer details as well as the tender tabulation statement after tender opening, from any remote location using internet access by visiting the website www.ireps.gov.in instantly after opening of the electronic tender box, by clicking on the icon.

Railways do not guarantee opening of the tenders on and after the specified date and time due to reasons beyond its control and hence tenders can be opened after the due date and time also. It will however, be ensured that no offers are submitted after tender closing date and time. Contractors cannot submit/modify any offer or attach any file to it after the closing date and time as stipulated in the tender notice. System does not permit any alteration, modification, deletion of any entry or condition, offered by the tenderer in the e-tender, after closure of the electronic tender box.

Tenderer are advised that while registering themselves on the IREPS website for participation in e-procurement system, the same address as furnished by them for getting digital signature from accredited agencies is to be filled up, to avoid any vitiation of information and consequent impairment in their credentials.

The Tender must be accompanied with the prescribed amount of Bid Security, as mentioned above against each Tender in any acceptable form as mentioned in the Tender Documents. Adjustment of Bid Security submitted with earlier Tender or recovery of outstanding bills for Bid Security will not be accepted and Tender without prescribed Bid Security will be liable to be summarily rejected.

The Railway reserves the right either to cancel or reject any or all the Tenders without assigning any reason thereof.

There will be an overall binding of Indian Railway's General Conditions of Contract for Works -2022 with upto date correction slips over the entire Tendering process & the entire Contract.

Monitoring of execution of this contract shall be done by SSE/20/C/KPA including formalities of contract.
