A letter has been received from RDSO on the subject cited above. A copy of the same is enclosed herewith for kind information and necessary action.

In this connection, it is informed that A&C Slip No. 1 to Report No. BS-41 R1 titled "Guidelines for Integrity Testing of Piles", issued by RDSO, contains revisions to Para 5.5.8 and Para 7.7. The same is enclosed for reference and compliance.

Further, a new Para No. 7.8 titled "**System Improvement Instructions**" has also been incorporated in Report No. BS-41 R1.

Accordingly, it is requested that the above RDSO instructions of conducting **CHUM Test** in 100% Piles may be included in all new tender cases. A new item may be incorporated in ongoing works and other System Improvement Instructions mentioned as Para 7.8 may be placed in tender document as special conditions in all new cases.

[ Serious Irregularities observed in Execution of Piles by Vigilance, Railway Board, CVC also insisted to monitor the quality of Pile work. The above System Improvements may be ensured to follow in all field units. ]



## Guideline for Integrity Testing of Piles

(Report No. BS: 41 R1)

ISSUED: November, 2023

### ADDENDUM & CORRIGENDUM SLIP No. 1 Dated 08.01.2026

**1. Modify the existing Para 5.5.8 as under:**

**5.5.8:** Cross Hole Ultrasonic Method (CHUM), tests shall be performed on 100% of piles. Accordingly, Access tubes shall be installed in 100% of the piles.

**2. Modify the existing Para 7.7 as under:**

**7.7:** Cross Hole Ultrasonic Method (CHUM), tests shall be performed on 100% of piles. Accordingly, Access tubes shall be installed in 100% of the piles.

**3. Add a new Para 7.8 as below:**

**7.8 System Improvement Instructions**

- a) Provision of permanent liner/casing with bored piles, if any, should not be left to the discretion of field engineers, it should be incorporated in drawing itself.
- b) A Method Statement should be prepared by the contractor for the pile foundation work detailing the sequence of operations, tools and equipment, roles and responsibilities of contractor's personnel, risk assessment etc. and approved by CPM/Dy CE before start of work. The method statement of **integrity testing** should also include equipment, specialized technical person and witnessing of Railway officials.
- c) The record of piling work should be maintained through pour card and stored in cloud-based storage for posterity. The report of **integrity testing** should be in specified format, maintained log wise and stored as permanent record.
- d) It is necessary that field engineers (XEN/AXEN & SSE/SE/JE) engaged in piling work should be imparted necessary training in execution of pile foundation including **Pile Integrity Test**. The contractor should deploy skilled, trained and experienced manpower for execution and supervision of piling work.
