

Minutes of the meeting held on 21.02.22 in the chamber of DRM-BRC regarding
Composite works

1. Tenders for the composite works are being dealt as per JPO circulated vide No. W 582/1(W6) dated. 03.07.2020 by HQ Office. Subsequently, special conditions have been prepared for electrical portion based on the JPO and has been approved by ADRM-BRC.
2. However, Sr.DEE(P)BRC is in the opinion for incorporating the special condition for summarily rejection criteria in case of non-submission of valid electrical licence by tenderer.
3. Engineering department is in the opinion that as there is no any provision of summarily rejection criteria in the JPO issued by HQ and also provision of change of electrical contractor with the approval of electrical department during the course of execution is already available. So, there is no need for incorporating summarily rejection criteria for non submission of electrical license being very small value of electrical portion.
4. DRM/BRC has instructed for considering the offers of tenderer where electrical license not submitted alongwith their offer subject to submission of the same before signing the contract agreement.
5. Sr.DEE(P)BRC has also raised some issues regarding execution of composite works where DRM-BRC has instructed to issue JPO by Engg. & Elect department by 15.3.22. This has the approval of DRM/BRC.
