13. The undersigned reserves the right to extend or cancel or reject the tender/tenders at any time without assigned any reason thereof. No cost whatsoever shall be claimed in such case by the bidder.
14. Earnest money deposit can be paid through offline or online mode.
 - (a) Earnest money deposit (EMD) can be paid through offline mode in the form of Bank Guarantee of nationalized/ scheduled Bank duly endorsed/pledged to **Executive Engineer, New Capital Road Division, Patna**. In offline mode EMD in form of Bank guarantee will be taken after award of work before agreement but scanned copy of Bank Guarantee should be uploaded with the tender.
 - (b) Earnest money deposit (EMD) can be paid through online mode also i.e. Internet payment gateway, Net Banking, NEFT/RTGS etc. Bids along with necessary online payment must be submitted through e-procurement portal www.eproc2.bihar.gov.in before the bid submission end date and the time specified. The department doesn't take any responsibility for the delay/Non submission of tender/Non reconciliation of essential online payment due to Non-availability of Internet connection, Network Traffic/Holidays or any other reason.
 - (c) The Bank Guarantee for EMD should be valid for not less than **165 days** after bid submission end date.
 - (d) The estimated cost may increase or decrease and accordingly Earnest Money may change.
15. (a) The cost of B.O.Q. and Bid Processing Fee is mandatory to be paid through online mode i.e. Internet payment gateway, Net Banking, NEFT/RTGS etc. The bidder shall also upload scanned copy of the acknowledgement/ Receipt of payment of cost of BOQ & Bid Processing Fee.
 - (b) A scanned copy of the instrument for Earnest money as described in SI. No.-14 above to be uploaded along with the tender document.
 - (c) In respect of 15(a) and (b) the bidder shall also upload details of the instruments including amount date, serial no, Bank on which drawn, office in favour of whom it is drawn/pledged and the place where they are payable.
16. As per RCD Lt. No.-163(E) Dt.-10.01.24, all original documents like Affidavit, Bank Guarantee (EMD) has to be submitted before agreement.
17. As per clause no. 3.3 of section 1(1TB) of the SBD, tenderers will have to declare by affidavit that they have not been declared defaulter or blacklisted by the State Govt./Central Govt./Public Undertaking. If such affidavit is subsequently found to be false, their tender shall not be considered and further legal action shall be initiated.
18. Before uploading tenders, bidders are advised to go through the conditions of the SBD uploaded with the tender document.
19. Bids from joint ventures are allowed for the works having estimated cost more than 10 Crore as per instructions mentioned in RCD, Bihar, Patna letter no. 8131(S)we Dt.24.07.2012
20. In percentage rate tender Bidder can quote any rate below BOQ Rate as per RCD Lt. No. 4439(E) Patna, Dt.-17.07.2023. Contractor will have to deposit additional performance guarantee for seriously unbalanced rate at the time of Agreement as per RCD Lt. No.-447(s), Dt.-16.01.2020.
21. As per RCD Lt. No. 2863(E) Dt. 07.06.2017, Similar nature of work shall be accepted.
22. As per RCD Notification No. 5737 (S) Dt. 07.05.2007, If Earnest Money is found invalid in verification the tenderers will be blacklisted.
23. The Successful bidder must have to submit character certificate issued from competent authority before agreement as per RCD Lt. No. 2033 (E) Dt. 11.04.2022.
24. As per RCD Lt. No. 7435(S) Dt. 14.08.2019, In exercise of the powers conferred under Article 166 (3) of the constitution of India, the Governor of Bihar is pleased to Substitute Contract Clause 25 of State SBD (Standard Bidding Document) by the following with effect from the date of its publication in the official gazette:-
"Contract Clause-25 Settlement of Disputes and Arbitration.

The Settlement of Disputes and Arbitration shall be done in accordance with the provisions made

in Bihar Public Works contracts Disputes Arbitration Tribunal Act, 2008."

25. As per RCD Lt. No. 3608 (E) dt. 22.05.2020, it is mandatory to attach Rs. 25/- Advocate Welfare Stamp on affidavit for Advocate Welfare Fund.
26. As per Prohibition, Excise & Registration Department, Bihar Notification No.-1026 Dt. 15.02.2013. It is mandatory that power of attorney, if applicable, should be on Rs. 1000/- stamp.
27. As per RCD Lt. No.-5355(S) Dt.-28.10.2021, Bidder is allowed to file objection to CE, South, RCD, Bihar, Patna within two days after the approval of technical bid.
28. As per RCD Lt. No.-2955 (S) Dt.-07.04.2025, successful Bidder must have to register and use CBuD App.
29. As per RCD Lt. No.-5446 (E) Dt.-25.09.2017, bidder should have valid license of energy issued by competent authority or have prior agreement with a contractor having valid license of energy issued by competent authority. (In case of Electrical utility shifting involved in the work)
30. Audit Report submitted by the bidders should be UDIN supported as per RCD Lt. No.-5023 (E) Dt.08.10.2024.
31. Bidders/contractors can access tender documents on the Website and must fill them and submit the completed tender documents in electronic form on the website itself, Bidders/Contractors shall attach scanned copies of all required papers and certificates as required in the eligibility criteria. All the uploaded document shall have the signature of bidder or their authorized signatories.
32. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of Download ability/ visibility of the scanned and uploaded file by them.
33. The bidder must use MS-Office 2007 or lower version.
34. No claim shall be entertained on account of disruptions of Internet service being used by bidder. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
35. Bids along the necessary online payments must be submitted through e-procurement portal www.eproc2.bihar.gov.in before the date and time specified in the NIT.
