**4.4** Offers in physical form will not be accepted in any case.

Demand draft for EMD & Tender Fee shall be submitted in Electronic format through online (by scanning) while uploading the bid & Bidder shall send the DD in original and other Documents Physical through R.P.A.D./ Speed Post / Courier so as to reach Executive Engineer, Nadiad Irrigation Division, Nadiad before the date of opening Price Bid.
