4.2 Tenderer shall submit their offer i.e. price bid in electronic format on above mentioned web site and date shown above after Digitally Signing the same.

4.3 Offers submitted without Digitally signature will not be accepted.

4.4 Offers in physical form will not be accepted in any case.

5.0 Submission of Tender Fees, Bid Security and other Documents:

Demand draft for EMD & Tender Fee shall be submitted in Electronic format through online (by scanning) while uploading the bid & Bidder shall send the DD in original and other Documents Physical through R.P.A.D. / Speed Post / Courier so as to reach Executive Engineer, Petlad Irrigation Division, Petlad before the date of opening Price Bid.

5.1 Tender Fee **Rs. 1500/-** by Demand Draft in favour of **“Executive Engineer, Petlad Irrigation Division Petlad ”**, payable at **Petlad** from any Nationalized /Scheduled Bank except Co-operative Bank. Demand Draft issued after the last date of submission of Bids will not be considered or accepted.
