9. Tender will be evaluated on Data / Details / Documents of the online offer only.
10. It is mandatory for all the bidders to upload their tender documents by on line (E-tendering) in scheduled time. No documents shall be considered physically which are mentioned for on-line submission only.

11. The bidders are required to fill up all the online annexure / forms. This is intended for transparency and speedy evaluation of the bids.
