4.3 Offers submitted without Digitally signature will not be accepted.

4.4 Offers in physical form will not be accepted in any case.

5.0 Submission of Tender Fees, Bid Security and other Documents:

Demand draft for EMD & Tender Fee shall be submitted in Electronic format through online (by scanning) while uploading the bid & Bidder shall send the DD in original and other Documents Physical through R.P.A.D. / Speed Post / Courier so as to reach Executive Engineer, Nadiad Irrigation Division, Nadiad before the date of opening Price Bid.
